

# Privacy Policy

This Privacy Policy ("Policy") applies to all clients registering for classes, and EFFECTIVE CPR TRAINING INC. ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include 67 NW 183 ST SUITE 116. The Company's application is a news and information application. By using the Company application, you consent to the data practices described in this statement.

## Collection of your Personal Information

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. ## Sharing Information with Third Parties

## Right to Deletion

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity;

- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest, free from any commercial constraints, solely for nonprofit research purposes;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with the user;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the reason for the collection of the information.

### **Children Under Thirteen**

The Company does not knowingly collect personally identifiable information from children under the age of 13. If you are under the age of 13, you must ask your parent or guardian for permission to use this application.

### **Email Communications**
