The application portal is open to accept training needs submissions for the Calendar Year 2020 funding year from **September 25, 2019 through October 30, 2019 at 7:59 PM Eastern Time.**

Eligibility

Funding is available to:

State or territorial (Puerto Rico) agencies with the regulatory/rating authority, or that provide a state laboratory service, to implement the National Grade “A” Milk Safety Program; and/or State agencies with the regulatory authority, or that provide a state laboratory service, to implement the National Shellfish Sanitation Program

Available Funding for Calendar Year 2020

Approximately \$2,250,000 in funding is available for the Calendar Year 2020 Grants for Training, Equipment and Other Needs.

Note that this is a substantial increase over funding available in previous years of this program.

Calendar Year 2020 Equipment Grants

For 2020 Calendar Year Awards, there will be separate application periods for training (Fall 2019) and equipment (Spring 2020) awards.


Reimbursement Tips for Current Grantees

Are you ready to submit your Reimbursement Request for reimbursement? Here are a few reminders for a quick and smooth reimbursement process:

- Find the Reimbursement Request under the “Reports” section within the grant management portal.
- Training Reimbursement Requests may include **up to five** trainings per report.
- Include documentation for **all** claimed expenses—with the exception of per diem if the GSA rate is being claimed.
- Ensure changes to the budget or scope of your project have been approved **before submitting for reimbursement**. Change requests should be submitted via email to msgrants@afdo.org.
- Training projects also require a separate, short Final Report that helps close out the project. Our team will add the Final Report **after** the last reimbursement request is approved.



Welcome

The U.S. Food and Drug Administration (FDA) in collaboration with the National Conference on Interstate Milk Shipments (NCIMS), the Interstate Shellfish Sanitation Conference (ISSC), and the Association of Food and Drug Officials (AFDO), have partnered to provide State Cooperative Program Grants for the Grade 'A' Milk Safety and National Shellfish Sanitation Programs.

Grant funding was available to state or territorial (Puerto Rico) agencies that have the regulatory authority to implement the Grade 'A' Milk Safety Program and/or the National Shellfish Sanitation Program.

Project Categories

- Training Grants - CY 2020 Training Needs Grants (\$500 up to a maximum of \$1,800 per person/per course) - Examples: Training needs to support Milk Sanitation Rating Officers (SRDs), Laboratory Evaluation Officers (LEOs), Shellfish Sanitation Officers (SSOs), and other Regulatory Staff Members to attend required trainings and other courses. Applicants will have the opportunity to request travel funds for your program's annual training needs to allow attendance at training courses, workshops, and seminars that advance the goals of the Grade 'A' Milk Safety and/or the National Shellfish Sanitation Programs.
- Equipment Grants - CY 2020 Equipment Grants - More information regarding the portal's additional opening is expected to be released in February 2020, with the portal opening in approximately April 2020.
