In accordance with your request, there is transmitted also a memorandum from the Chief of the Division of Sanitation of this Department, concerning the cost of inaugurating a program for the more effective control of the sanitary quality of milk and cream consumed in this State. Highly Pathogenic Avian Influenza (HPAI) is a disease that is highly contagious and often deadly in poultry, caused by highly pathogenic avian influenza A (H5) and A (H7) viruses; it is also known as bird or avian flu. HPAI viruses can be transmitted by wild birds to domestic poultry and other bird and animal species. Although bird flu viruses do not normally infect humans, sporadic human infections have occurred. #### What's New

June 28, 2024

The FDA, along with our federal partners at the U.S. Department of Agriculture, is announcing results from a first-of-its-kind study using the process typically used by commercial milk processors. The intention of this study was to further confirm that pasteurization is effective at inactivating Highly Pathogenic H<sub>5</sub>N<sub>1</sub> Avian Influenza (H<sub>5</sub>N<sub>1</sub> HPAI) virus in fluid milk and other dairy products made from pasteurized milk.

<u>The study</u> – the only one to date designed to simulate commercial milk processing – found that the most commonly used pasteurization time and temperature

WHERE DID WE LAND:



- FDA/USDA STILL ARE VERY INTERESTED IN PREVALENCE EVEN THOUGH PASTEURIZATION IS OVERWHELMINGLY EFFECTIVE AT INACTIVATING THE VIRUS.
- FDA/USDA BELIEVES SAMPLING PRE-PAST. SILOS STILL MAKE SENSE

States will sample 1 silo at every plant receiving Grade A Milk 2

States will be reimbursed and provided sampling supplies

The Sampling Study will be Double-blinded 4

Samples will be taken over a 6week period
