


How would you rate the 2022 NCIMS Virtual Symposium overall? 67 responses


How was the length of the symposium overall?

Was the information provided helpful to better understand the work of NCIMS? ⁶⁷ responses






FDA as critical partner Scientific Conference Grant (FDA-ORA)



COVID-19 Pandemic Impacts on Grade-A regulatory activities

- Request for Emergency Consideration (Procedures, Section IV (B.5)) Request to PHS/FDA "In the event of a declared public health emergency or natural or man-made disaster....if the State is not in a position to operate the program in full compliance with NCIMS program requirements..."
- Reminder sent to states by NCIMS in March 2020
- FDA issued M-a-99, granting this ability to TPCs/SSCs during the COVID-19 emergency (March 2020)
- FDA issued M-a-100, Alternate emergency procedure for provisional certification of new LEO candidates (November 2020)



- Established by Delegates at 1991 Conference
- ► FDA Contract with 3rd Party
- GLH Incorporated managed the NMDRD for 30 years
- Contract expires March 31, 2023


