**Item No.2(b):**

**To consider the letter dated 08/05/2024 received from Vidarbha Yuvak Vikas Sanstha's , Buldhana running Mukul Wasnik College of Law, Buldhana (LLB5049).**

"Discussed.

The Institute has submitted the proposal for approval of fees for the academic year 2024-2025 in respect of L.L.B. 5 years course. While scrutinizing the proposal it was noticed that the Institute has not submitted proposal for approval of fees for the academic year 2022-2023 & 2023-2024. It was therefore decided to issue notice seeking explanation from the Institute. The Secretary of the Trust running the Institute responded to notice. In brief it is stated that the Institute has opted for no upward revision of fees for the academic year 2022-2023 and 2023-2024. It was brought to notice that in the meeting of the Authority held on 01/03/2024 the Authority has resolved to allow the Institute to submit the proposal for the academic year 2022-2023 by opening the link either to opt for 'No Upward Revision' of fees or to submit the proposal for 'Upward Revision' of fees with penalty of Rs. 1 lac per course or Rs. 5,000/- per course to opt for no upward revision of fees. The inspite of decision communicated to the Institute vide letter dated 06/03/2023 the Institute has neither opted for no upward revision of fees nor submitted the proposal for upward revision of fees.





Considering the fact that the fees of L.L.B. 5 years for academic year 2021-2022 was approved by the Authority, the Institute is entitled to opt for no upward revision of fees for the academic year 2022-2023. The Institute is not entitled to seek successive No Upward Revision of fees in terms of sec 14(1)(b) of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015, the Institute is required to submit the proposal for the academic year 2023-2024. The option is available with the Institute either to submit the proposal for upward revision of fees for the academic year 2022-2023 and opt for no upward revision of fees for academic year 2023-2024 or vice versa. In absence of the proposal being submitted for the preceding two years the fees for the academic year 2024-2025 cannot be finalized by the Authority. The Institute is advised to take appropriate decision to submit the proposal or go for upward revision of fees as discussed above and make the request accordingly to Authority so that Authority can take the appropriate decision.
