2019 VENDOR RULES

VENDOR hereby contracts with FUN'D the FOURTH COMMITTEE for space at the Family Fun Festival at the Kite Field in the Brookings Harbor as follows:

1. VENDOR agrees to use booth space as described. This is a family event. FUN'D the FOURTH COMMITTEE has the right to decline/remove/disallow any signage, posters, materials or other visual/audio forms of communication they feel not family friendly or offensive.
2. Neither the FUN'D the FOURTH COMMITTEE and the PORT OF BROOKINGS-HARBOR will be responsible for any injury which may arise to VENDOR, their employees, agents, guests or customers; or for the loss, theft of or damage to any food, display, merchandise, samples or vehicle from any cause whatsoever while in transit to or from, or while participating in the Festival. By executing this contract, VENDOR agrees absolutely and irrevocably to waive and release any claim it may have against the FUN'D the FOURTH COMMITTEE and the PORT OF BROOKINGS-HARBOR, their officers, officials, agents or employees.
3. When ACTS OF GOD or any other causes not within the control of the FUN'D the FOURTH COMMITTEE and the PORT OF BROOKINGS-HARBOR make it impossible for the VENDOR to occupy the Festival premises, then in such case the FUN'D the FOURTH COMMITTEE and the PORT OF BROOKINGS-HARBOR, their officers, officials, agents or employees are jointly released from any and all claims for damages which may arise as a consequence thereof.
4. The VENDOR also agrees to the following conditions of this contract:
 - a. Set-up on July 4th from 9am-11am unless otherwise arranged with us. Teardown July 4th after 7pm.
 - b. The FUN'D the FOURTH COMMITTEE and the PORT OF BROOKINGS-HARBOR shall be entitled to close an exhibit at any time for failure of VENDOR to perform, observe and comply with any term set forth in the contract.
 - c. If for any reason the FUN'D the FOURTH COMMITTEE and the PORT OF BROOKINGS-HARBOR determines that the location of the Vendors should be changed, FUN'D the FOURTH COMMITTEE and the PORT OF BROOKINGS-HARBOR reserves this right.
 - d. All pertinent laws, ordinances and regulations pertaining to health and public safety shall be strictly observed.
 - e. VENDOR will cooperate by keeping Vendor area clean.
 - f. Overnight security is not provided. As an exhibitor, you understand there is always a risk in public places.
 - g. VENDOR will be given 2 vehicle parking passes prior to the event. Passes must be displayed in front dash of vehicle to gain entrance and to park in reserved lot. Please pick up your passes at the Brookings – Harbor Visitor Center June 24-29th from 10am-3pm.
