### SPRING FEVER - URGENT!

We need to approve the updated CC&Rs! We **only have 40%** of the necessary ballots. Get your approval notarized and returned to Sterling Real Estate Management ASAP.

- <u>Why did they get updated?</u> The CC&Rs are currently overly constrictive ("All window coverings visible from neighboring property must show beige colors..."), contradictory, and in some cases, flat-out wrong.
- <u>Why the rush?</u> It is required to get **75% APPROVAL** in order to change our CC&Rs.
  At the time of approval, it must be current owners and these votes must be checked by our lawyers. Every house sale starts the process for that property over again.
  - 2) This cannot remain open indefinitely. A lack of approval leaves us with rules that don't make sense.
- <u>What if I have questions?</u> The Board has been organizing open houses to address questions. They have also been working to provide a notary service, free of charge to members, at the town halls when possible. Adam at Sterling Real Estate is also available to answer questions.

- As the weather warms, the plants we love are sprouting. And the ones we don't want are coming, too. Remember to stay on top of unwanted weeds.

#### **CHANGING WINDS**

- The overpass bridge will be replaced this summer. The current predicted time we will need to detour through Parks is around 9 days. Dates have not been determined yet.
- The county and the POA board are negotiating how to best address the cluster mailboxes. There are many details regarding location, cost, maintenance, and other topics that are being discussed.
- The main field near the playground will be aerated and seeded again soon. After the extensive repairs to the pumps, pump house, and irrigation systems, which required the lowering of the lake and turning off the irrigation for a lengthy time, we have been working hard to bring the grass back in the common areas.

- Repairs are being done to the irrigation system, aeration system, and the fountain spouts.
- While storage of RVs (and ANY trailers until the CC&Rs are approved) is still <u>not allowed</u>, the POA understands the need to clean and perform minor maintenance of RVs, as well as visiting guests. These exceptions are allowed as long as the homeowner informs the property manager ahead of time, including the duration.
- We have secured a company to repair the buckling sidewalk around the lake.
- We are currently moving the necessary irrigation lines in order to complete the path around the lake.
