### GOVERNOR HOCHUL'S FIVE-POINT PLAN TO FIGHT ORGANIZED RETAIL THEFT:

1. Increases criminal penalties for anyone who assaults a retail worker by elevating it from a misdemeanor to felony. Any person who causes physical injury to a retail worker performing their job will be subject to this new felony.

2. Allows prosecutors to combine the value of stolen goods when they file larceny charges. The Budget allows retail goods from different stores to be aggregated for the purposes of reaching a higher larceny threshold when stolen under the same criminal scheme.

ongoing fight against organized retail theft was announced by Governor Kathy Hochul and Queens District Attorney Melinda Katz. The charges allege a sprawling, multi-year, international operation that saw upwards of \$2 million in retail goods stolen by organized crews. The case includes the first-ever charges under Governor Hochul's newly enacted law criminalizing the fostering of stolen goods sales, a key component of Governor Hochul's five-point plan to fight organized retail theft. The new protections against retail theft signed into law with the FY25 Budget included over \$40 million for law enforcement including dedicated Retail Theft Teams within State Police, whose work by undercover units led to these charges. It also prioritized protecting frontline workers by increasing the penalties for assaulting a retail worker.

"New Yorkers are sick and tired of the retail theft that has been plaguing our businesses and communities - I promised we would fight it head on, and now we are seeing results," Governor Hochul said. "Earlier this year, we gave law enforcement and store owners the tools and support needed to help meet this challenge, and today with our partner District Attorney Katz, we're taking down a massive retail theft ring stretching from New York City to Maryland to the Dominican Republic. Keeping New Yorkers safe is my number one priority, and as we enter the holiday shopping season, we will continue focusing our efforts to ensure people feel safe walking into stores and business owners can focus on serving their customers instead of locking up everyday items like toothpaste and deodorant."

The defendants allegedly sold stolen merchandise including high-end makeup, perfume, beauty products, designer clothing and accessories, locally and abroad under the name Yvelisse Fashion, LLC. They allegedly directed retail theft crews to steal specific merchandise and then sold the stolen products from their home and a storefront in the Dominican Republic. The couple is also alleged to have paid truck drivers to divert products bound for retailers such as Sephora and Ulta Beauty from manufacturer warehouses directly to locations under their control. Among the charges brought against the defendants is fostering the sale of stolen goods, the first time this newly adopted crime has been charged in New York.

The defendants allegedly purchased large quantities of stolen retail cosmetic goods, beauty products, perfume, designer clothing and accessories from numerous theft crews that stole from retailers up and down the East Coast. They also organized the large-scale theft of merchandise directly from manufacturers before it was distributed to retail outlets. They received approximately \$50,000 worth of stolen goods per week for which they paid the theft crews approximately 10 to 15 percent of retail value. The goods were then catalogued and sold in New York through online advertisements as well as from a brick-and-mortar boutique called Yvelisse Fashion in Santiago, Dominican Republic.

The investigation was conducted by the New York State Police Special Investigations Unit including members of the Governor's Retail Theft Force under the supervision of Major Samuel P. Spezio along with members of the Queens District Attorney's Detective Bureau under the overall supervision of the Chief Investigator of the Detective Bureau Robert LaPollo, as well as personnel from the Homeland Security Investigations, New York Border Enforcement Security Task Force's Trade Enforcement and Interdiction Group and Customs and Border Protection. Retailers Ulta Beauty, Sephora, Macy's, American Eagle and Victoria's Secret assisted in the investigation. Governor Hochul secured new protections against organized retail theft that were signed into law with the FY25 Enacted Budget. This comprehensive approach puts more power in the hands of law enforcement, prosecutors and business owners - targeting every area of vulnerability. The new protections include increased criminal penalties for anyone who assaults a retail worker elevating it from a misdemeanor to a felony, and includes a \$5 million tax credit to help small business owners invest in added security measures. Governor Hochul's FY25 Enacted Budget made historic investments in public safety and builds on three years of progress driving down crime statewide.

3. Makes it illegal to foster the sale of stolen goods to go after third-party sellers. A person will be found guilty if they use any website or physical location to sell stolen goods.

4. \$40.2 million for dedicated Retail Theft Teams within State Police, District Attorneys' offices and local law enforcement, including 100 New York State Police personnel dedicated to fighting organized retail theft.

5. \$5 million tax credit to help small businesses invest in added security measures such as cameras. To help alleviate the burden on small businesses for additional security measures, the Budget creates a \$3,000 tax credit for any small businesses who spend the threshold amount of money on retail theft prevention measures.

## THE HOLIDAYS REIMAGINED

For many years, I have written about the holidays and provided tips on how to make them less stressful or more akin to the cherished memories that linger year after year. This year, I am motivated to invite your consideration of some new ways to envision the holiday season. Among the suggestions that I will be sharing, you might just find your own special ways to update and enhance your approach to the time honored pursuit of holiday cheer.

My suggestions are organized around the principle of sustainability. I have been pondering how the ever increasing demands on our time, energy and pocketbook drive decisions about what to do and how to do it. More and more, we may find that we are in need of new ways to handle our present day reality while clinging to the need for connection and celebration. There is no uniform tradition for our diverse society; nor are there singular views about what the holidays mean on an individual or collective basis. Of course, this makes for a complex view, but it may also open us up to consider a wider variety of options.

To get you started on your own version of a reimagined holiday season, let me first add that many folks are in different cities, countries and locations making the task of coming together more challenging than it may have been when we resided in close knit communities, villages or towns. Also, certain versions of the holidays include travel plans for those seeking adventure and exploration of new and different destinations or experiences. Traditions and rituals connected to the winter season may focus on holy days, feasting, fasting, chanting, singing, lights, holiday parties, gift exchange or the solstice. Nature's changes may also prompt opportunities to go within for deeper reflection. Given all of the possibilities for how and why we celebrate, I believe there is still room to advance some sustainable features that nurture us and the planet.

Natural decorations that include holly leaves, evergreen branches, plants or fruits for centerpieces can bring seasonal expressions of beauty right to the table. To brighten up the winter season, you can use candles that are carefully placed to provide a warm glow to interior spaces. Battery operated candles can simulate the same effect and many of them look exactly the same as the real thing. Also, I have discovered that LED lights are 90% more efficient than regular lights.

When selecting gift packaging, you might want to consider reusable products like

cloth bags, recycled glass or metal containers. I clean and repurpose containers all the time to hold items such as baked goods; dried fruit and nuts, as well as small gift items such as jewelry or other trinkets.

Members of my extended family have wisely used a "dish sign up list" to reduce food waste. The option to freeze or create new dishes from leftovers is yet another way to prevent food from being thrown into the garbage. My favorite alternative is to compost as much as possible of what remains after a family gathering. I also hope that restaurants are using food rescue services like City Harvest or Food Recovery Network to get leftover food to those who could use it.

An option for a tree might be a potted one with roots that can be planted after the holidays. Artificial trees have been around for a long time and many choose this as an important part of celebrating the holidays. If the traditional tree is part of the picture, experts say that it is important to "Place it away from fireplaces, radiators, portable heaters, heater vents, electronics and electrical equipment;" and to keep the stand filled with water so that it does not dry out causing a potential fire hazard. It would be helpful to locate one of the tree mulching sites through the NYC Parks Department that sponsors "Mulchfest" to find out where you can take your tree at the close of the holiday from December 26, 2024 until January 12, 2025. It is reported that 46,626 trees were recycled last year. We are being invited to "top this number" this year.

Although I have not fully embraced the e-card for holiday greetings, I do enjoy receiving them from friends, family and neighbors. One adjustment that I have made has been to mainly send Thanksgiving cards because that is a shorter list. I suspect that it is just a matter of time before more people latch on to the e-card option for sharing the spirit of joyful connection. Wrapping paper and boxes are probably more of a problem than greeting cards when thinking about how they end up curbside and ultimately in landfills. Curtailing the conspicuous consumption of countless rolls of wrapping paper, boxes or packages would definitely be a positive step forward for our planet. In this regard, I also recommend the use of paper cups or plant-based utensils over plastic. For years, I have done my best to limit plastic at family gatherings and events. When entertaining at home, I use regular plates and glassware and consider the chore of washing them as a gift that honors my guests. Taking an eco-friendly approach, by reducing the demand for plastic products that often end up in our oceans and waterways, is a great holiday gift to Mother Nature.

Ecotourism holidays and "responsible travel" that factors in a respect for natural settings, wildlife and people is yet another way to imagine the holidays. There are many exciting destinations to explore. You need not travel far. Often such opportunities are within miles of where we live. This can be the case for those who want to discover more about New York State's natural wonders. Neighboring states also have an abundance of sights and experiences. Traveling abroad to an "agriturisimo," or working farm, is something that I have done and highly recommend. Finally, if the holidays take on the "shop 'til you drop" quality, perhaps you will consider a different approach that allows you to press "pause" on hectic holiday shopping that adds credit card debt that will undoubtedly greet you on New Year's Day. Instead, I invite you to join us on Saturday, December 7th from 5-7pm for a "Holiday Shoppers' Swap" where we will have some fun creating a marketplace of new or slightly used items to sell or trade. This event is free and open to the public and has been a mainstay of the holiday season for over ten years. 


