

Governor Kathy Hochul signed legislation to increase road safety by extending existing red light camera programs across the state and establishing a new red light camera program in the Hudson Valley. This includes the largest expansion of the red light camera program in New York City's history. The action builds on Governor Hochul's legacy of authorizing communities across the state to utilize camera technology to maintain traffic safety and protect New Yorkers. Governor Hochul also signed legislation that will protect children on buses and other measures designed to keep students safe and hold reckless drivers accountable.

"The safety of all New Yorkers is my top priority and we know that red light camera programs are effective in protecting New Yorkers from dangerous drivers," Governor Hochul said. "Today I am extending the authorization of programs across New York and establishing an additional program to maintain our progress on traffic safety, while creating new protections for school aged children on the road."

This legislation package will extend, expand, or create red light camera programs in many areas including the following:

#### New York City - extended and expanded

#### Nassau County - extended

Legislation S2812A/A5259A extends authorization for New York City's existing red light camera program until 2027 and increases the maximum number of intersections with a red light camera from 150 to 600.

Legislation S.9504A/A.3120A increases penalties for overtaking and passing a school bus. The fine for a third or subsequent violation within three years will rise from \$1,000 to \$1,500. This targets repeat offenders specifically.

Legislation S9361/A8557 requires all passengers on charter buses over the age of 8 to use the seatbelts provided.

Lastly, Legislation S760B/A402B expands the reckless driving statute to include parking lots. Parking lots will be defined as private property with capacity for four or more cars, contiguous to premises and a roadway, parking lots adjacent to one- or two-family residences are exempt.

## FREE CUNY AND SUNY APPLICATIONS

Governor Kathy Hochul announced that the State University of New York, the City University of New York and over 50 private colleges and universities throughout New York State have again come together to offer free application opportunities for high school seniors during New York State College Application Month.

"Ensuring that every student has the opportunity to pursue higher education is a top priority for New York State," Governor Hochul said. "College Application Month isn't only about waiving fees — it's about breaking down financial barriers and opening doors to future opportunities. We're empowering students across the state to take the first step toward achieving their educational and career goals while removing the financial obstacles that may deter students from pursuing higher education."

The State University of New York (SUNY) will waive up to five application fees per student across its 64 colleges and universities through Nov. 3. The City University of New York (CUNY) is waiving application fees across all 25 campuses for high school seniors attending New York City public schools through Nov. 15 and from Nov. 4 to Nov. 15 for all New York State residents applying as a college freshman. CUNY further guarantees admission to all seven of its community colleges for all NYC Public Schools graduates, while private institutions across the state are offering fee waivers that vary by campus.

To assist students with their academic goals, the NYS Higher Education Services Corporation (HESC) and academic partners will offer over 65 virtual and in-person events. These events aim to support students through their college applications, encourage students to learn more about New York State financial aid, and inform them about their college options. Additional assistance with college applications and information on related events can be found at SUNY edu and CUNY edu.

New York State's College Application Month (CAM) is part of the national American College Application Campaign, which began as a pilot at a single high school in North Carolina in 2005 and has since expanded to all 50 states and the District of Columbia. Coordinated by HESC in partnership with the NYS Education Department, SUNY, CUNY, the Commission on Independent Colleges and Universities, the Association of Proprietary Colleges, the NYC Department of Education and community organizations. CAM encourages high school seniors — especially those from low-income families, first-generation students, and those who may not otherwise apply — to submit college applications early. To date, the national campaign, sponsored by ACT's Center for Equity in Learning, has helped nearly 4.7 million students submit over 8.7 million applications.

### MANAGING YOUR EVERYDAY STRESSES AND ANXIETIES

Everybody deals with stress and anxiety, however the key is to know what to do when you're stressed out. It is not always easy to keep your feelings from getting the best of you. With this in mind, here are seven tips that a person can use to help manage their daily stresses and anxieties before they get out of control.

- 1. **Get all of the facts of the situation**: Gathering the facts of a certain event can prevent us from relying on exaggerated and fearful assumptions. By focusing on the facts, a person can rely on what is reality and what is not. Most importantly, do not focus on your fearful thoughts when you're stressed out.
- 2. **Take a break**: Sometimes, we get stressed out when everything happens all at once. When this happens, a person should take a deep breath and try to find something to do for a few minutes to get their mind off of the problem. A person could take a walk, listen to some music, read the newspaper, or do an activity that will give them a fresh perspective on things.
- 3. Carry a small notebook of positive statements with you: Another technique that is very helpful in managing fear is to have a small notebook of positive statements that makes you feel good. Whenever you come across an affirmation that relaxes you, write it down in a small notebook that you can carry around with you in your pocket. Whenever you feel depressed, open up your small notebook and read those statements.
- 4. **You can't predict the future**: While the consequences of a particular fear may seem real, there are usually other factors that cannot be anticipated and can affect the results of any situation. We may be ninety-nine percent correct in predicting the future, but all it takes is for that one percent to make a world of difference.
- 5. Challenge your negative thinking with positive statements and realistic thinking: When encountering thoughts that make you fearful or depressed, challenge those thoughts by asking yourself questions that will maintain objectivity and common sense. Focus on the reality of your situation and not on your thoughts. Your fearful thoughts can make things worse so try to focus on something positive when you get anxious.
- 6. **Divide your activities into separate steps**: When facing a current or upcoming task that overwhelms you with a lot of anxiety, divide the task into a series of smaller steps and then complete each of the smaller tasks one step at a time. Completing these smaller activities will make the stress more manageable and increase your chances of success.
- 7. **Take advantage of the help that is available around you**: There are many individuals who have been expertly trained in the field of psychology to help you find ways to manage fear and anxiety. Seek out someone whom you trust to provide sound advice and guidance. This same professional can also help you create an action plan for dealing with your fears and anxieties in the future.

#### LIVING THE VALUES OF PEACE

The cause I believe in is world peace which sounds wholly unimaginable. It's something like declaring a belief in the Tooth Fairy; Easter Bunny or Santa Claus. I have decided to risk the scrutiny and sense of disbelief to attach this calling to an understanding that the most important thing I can do is step out on faith using what I know to support a focus on teaching children the values that give peace a chance. Something urges me to believe that peace is more than simply a dormant relic of unrealized potential. For years, I have thought and written about the need for peace education in the schools, as just one starting place. For an equal amount of time, I thought I would have to be the one to develop a curriculum to get things started; all the while knowing what a major undertaking that would be. Then over the past few months, I had the sudden recollection that I was a part of a United Nations special initiative many years ago that launched a peace education curriculum called "Living Values." Consequently, I found a copy of the curriculum that I was given. I dusted it off and realized that I had what was needed all along. This comprehensive curriculum targets developmentally appropriate approaches to reaching children from about 3 to 18 with value-based lessons in building a foundation for peace. With this discovery, I commenced to formulate a plan to see how I could resurrect the content and distribute it to those who could implement it with children in schools.

In preparation for sharing the "Living Values" curriculum, I reached out to those who I knew back in 1997 when I was one of many educators who participated in an outreach event at Harmony House in Great Neck. I was immediately connected with information and contacts that allowed me to find out that the work of sharing this curriculum has continued for all these years in countries all over the world. This revelation and the prompt responses that I got to my inquiries from those involved in this work, convinced me of the importance of doing my part to connect people to the material and enlisting supportive partnerships to further extend the effort.

Living Values Education has become a Non-Governmental Organization (NGO) of the United Nations and I want to share a link to the most current enhanced material that is available free to download from the Living Values Education website:

As a retired educator and administrator, I am excited to share this curriculum because it focuses on values that can be helpful to teachers as they seek to prepare children with the constructive tools for a productive life in the community. The targeted values and activities presented in the curriculum focus on peace, respect, love and caring, tolerance, honesty, happiness, responsibility, simplicity, caring for the Earth and Oceans, cooperation, humility, compassion, freedom and unity. The Living Values curriculum contains a comprehensive array of information and activities and I hope that, like me, others will see the great value in preparing our young people for a peaceful future based on the tools and learning experiences in the Living

I am sharing this information at this time when there are so many of us hearing the disturbing news of global conflict and social strife. Perhaps, like me, you are wondering what we can do to address these sweeping problems. I am confident that although we are living through troubling times, putting this curriculum into practice gives us an opportunity to take one significant step forward toward sustainable solutions for our children's future. Back in 1997, I pledged my support to circulating the curriculum in places and spaces where children could learn how to internalize the values of peace. Over the years since then, we have experienced many changes; yet, today I find an even greater need for the content of this curriculum than I did in 1997; as well as an urgency to get it into the hands of as many educators, parents and community leaders as possible. If you know of others who might be interested in helping to put this curriculum into use, please share the information.

Over the past few months, I launched my own campaign to share Living Values with the Chancellor of the New York City Department of Education and received a reply indicating that the information was forwarded to the curriculum department for review. Over the summer, I got a request from a former colleague and member of the faith-based community who was interested in the curriculum for use in her ministry. She received the materials and I am excited about the possibilities for such a grass-roots effort to spread the word about the importance of peace education for our children.

My most recent steps resulted in me personally delivering material on the curriculum to the principals at three local schools. During a recent vacation in Europe, I got to speak to fellow travelers about the Living Values peace education curriculum, and was delighted to get an email from one of them asking me about how things were going with my plan to share the curriculum with the New York City school system. I was very happy to report the progress, along with my thanks for her interest. This small gesture of reaching out to me suggests that there are others who care. It is gratifying for me to think that in some small way, I may be continuing to serve the needs of our children even though I am retired. We all have a part to play no matter what our role is. Let's keep talking and thinking about ways to make peace a reality for ourselves; our families, neighbors, communities, nations and the world.






