Legislation businesses in New S.033/A.3456 will create a small business liaison with the Departments of Agriculture and Markets, Environmental Conservation, Labor, Transportation, and Taxation and Finance. Legislation S.113a/A.6508a requires the Secretary of State to confirm receipt upon receiving a statement of filing and include useful information for all businesses that apply to reserve a name, including but not limited to contact information for the local Small Business Development Council, local Entrepreneurial Assistance Program, Business Mentor NY, and Empire State Development.

"After helping my mom start a flower shop, I know how much hard work and dedication it takes to operate a small business," Governor Hochul said. "Small businesses have been hit hard over the past two years, and New York must do everything in our power to help them survive - and thrive. This legislative package will ensure State government can continue to be a partner and an advocate for small businesses across New York."

Legislation S.033/A.3456 amends the State Administrative Procedure Act to create a small business liaison with the Departments of Agriculture and Markets, Environmental Conservation, Labor, Transportation, and Taxation and Finance by designating an existing employee to serve in this capacity. The liaison will assist small businesses in a variety of ways such as serving as the primary contact for small business, being equipped with basic information on the agency, helping small businesses navigate the agency bureaucracy, hearing and reporting concerns of small business, advocating within the agency on behalf of small businesses, initiating and encouraging small business education and outreach on behalf of the agency, and collaborating with agency staff on any small business regulation. Legislation S.113a/A.6508a amends the Business Corporation Law and the Limited Liability Corporation Law by requiring the Secretary of State to confirm receipt after receiving a statement of filing. Included with the confirmation will be information on some of the many small business support programs offered by New York State including but not limited to contact information for the regional NYS Small Business Development Center, regional NYS Entrepreneurship Assistance Center, Business Mentor NY, and NYS Empire State Development.



BOOST UP NEW YORK

On December 2nd, Governor Hochul launched the statewide "Boost Up, New York" campaign to urge New York adults to get their booster dose for better protection against COVID-19. As the state monitors for the Omicron variant, the new education and advertising effort reminds New Yorkers that a boost against COVID-19 is needed to maximize protection, prolong the vaccine's durability, and help safeguard communities and loved ones against the virus.

"With this campaign, we are getting the message out with banners and displays to get people excited about booster shots as they get ready to celebrate the holidays," Governor Hochul said. "If you are over 18, you can get the free booster dose immediately. It will give you that extra protection, and it also helps to protect your loved ones. This is the ultimate act of kindness that you can exercise this holiday season." The "Boost Up, New York" campaign will be featured at popular grocery stores, malls, and transit stations statewide including on bulletins, posters, and multimedia screens. The program will also span online advertising to reach adults on search engines and social media channels. All campaign activations will include a QR code or hyperlink so New Yorkers have easy-to-access scheduling information, as well as resources for those looking to learn more about the importance of getting a booster. With increased urgency and a timely message, the program will kick-off December 6 and run for four weeks. In addition to getting a booster, Governor Hochul and the State's Department of Health encourage all New Yorkers to follow and share with others this important information for healthy holiday gatherings: All New Yorkers 5 and older should get fully vaccinated.

- All New Yorkers 18 and older who are two months past the Johnson & Johnson vaccine or 6 months past the Pfizer-BioNTech or Moderna initial vaccine series should get their booster dose.

- All New Yorkers 6 and older should also get their flu shot.

- New Yorkers should get tested after traveling and before seeing family.

- All travelers, domestic and international, should continue to follow all CDC travel requirements.

- New Yorkers who don't feel well should stay home

- Wear masks in public indoor spaces and wash hands regularly.

If you are over 18, you can get the free booster dose immediately. It will give you that extra protection, and it also helps to protect your loved ones. This is the ultimate act of kindness that you can exercise this holiday season. The COVID-19 vaccine and booster doses are free and widely available statewide at pharmacies, local health departments, clinics, Federally Qualified Health Centers, state-run mass vaccination sites, and other locations across New York State. New Yorkers can boost up or get vaccinated by visiting vaccines.gov, texting their ZIP code to 438829, or calling 1-800-232-0233 to find nearby locations. New Yorkers can also visit the Am I Eligible page or call 1-833-NYS-4-VAX to schedule a booster or vaccine appointment at a state-run mass vaccination site. Eligible New Yorkers can receive any of the FDAapproved or authorized COVID-19

REMEMBERING A HOUSING JUSTICE CRUSADER: GERARD FROHNHOEFER



The holidays are a time for remembering; whether we remember childhood gifts or favorite films. This holiday season, I am remembering a cherished former colleague and friend who recently passed away just months after we spoke on the phone and he told me that he was ill. I just knew that he would prevail, but when I received the email with the sad news, my heart sank. I have since rallied to reclaim the joy and enthusiasm that marked our friendship. I met Gerard "Gerry" Frohnhoefer, who like me was a former Youth Coordinator back in the 80's, at a reunion. He came to the event with a petition to sign that raised issues about affordable housing. We had never directly worked together; however, I was immediately impressed with his passion for the cause of housing justice, so I took copies of the petition to circulate. This common ground was the basis of the friendship that followed.

I facilitated his presentation at a Justice for All Coalition meeting where he shared how pre-fabricated modular homes could be provided to meet the demand for affordable housing. He was my main resource for insightful ideas about how to bring more equity to housing access. Gerry also advocated for home ownership. I can recall him saying; "When you rent, you don't even own the paint on the walls." I knew that he taught at La Guardia Community College, and his level of energy and innovation was only exceeded by his faith-based beliefs which we also often discussed over the phone, or over coffee. He had a passion for helping others and possessed a strong commitment to guiding his students toward the future.

In 2020, I did a four part series on homelessness and I interviewed him to integrate his knowledge and experience with the topic. During our first discussion, he shared his opinion that homelessness is a phenomenon that has been "institutionalized." He favored permanent solutions, not quick fixes. In Part Two of the series, he went on to say: "There is a lot of waste going on" Gerry said: "There is a concentration of resources at the top of organizations that people are not talking about." He felt strongly that the nature of bureaucracies creates the tendency to use the money intended for addressing the homelessness problem instead to create high level city government administrative positions. He suggested that "non-profits" might best serve the need. A failure to take swift comprehensive action with permanent solutions when the problem of homelessness was smaller has given way to what Gerry referred to "a multi-generational, institutionalized emergency system with no exit plan," and no "equity" for the people trapped in the system. Gerry's ideas about a new form of modular, subsidized, affordable public housing on public land with variable agreements that could include an option to buy, included his vision of mixed use buildings that could provide social services scaled at the level of human needs for shelter, safety, access to care and support for health, spiritual, mental and physical well-being. He shared his ideas and always welcomed discussion to further his vision of "Villages of Hope." I was not surprised to find that in lieu of flowers, his family preferred that donations be made to "Homes for the Homeless" in his memory.

In this season of giving, I applaud Gerry's vision and his humanity because through them he expressed his hope for the world; not just a single segment of the human family. His words always rang with a spirit of compassion and a desire to help. He will forever be my real life personification of the Jimmy Stewart character George Bailey in "It's A Wonderful Life." The story summary notes that "Without George, Bedford Falls becomes "Pottersville," a hive of sin and villainy." The "picturesque storefronts" on the main street of Bedford Falls, through the greed and avarice of one man, had the potential to turn the town "into a drag of "jitterbug" bars, billiard halls and strip clubs." The Bailey Brothers Building and Loan depicted in the film, gave hope to take people out of poverty, despair and dire circumstances; lifting them and their families up. It provided a mortgage-lending alternative and created the possibility of home ownership. I can't help feeling that Gerry would align with the values conveyed in this classic movie. If I could momentarily lapse into the fantasy of this poignant film, I would imagine that when the holiday bells ring this year, there will be an angel named Gerard Frohnhoeffer who gets his wings. Applause. Applause. Thank you, Gerry!

SCRIE/DRIE: Apply for the SCRIE or DRIE exemption to keep your rent from increasing. (3) Live in a rent-regulated apartment (see website for specifics), and (4) spend more than 1/3 of your income on rent.

HELP DEALING WITH SUMMONS ISSUES

This December, State Senator Joseph P. Addabbo, Jr. is partnering with the NYC Office of Administrative Trials and Hearings (OATH) for an event at his Howard Beach Office to provide residents with assistance for their city summonses and hearings.

OATH is New York City's central, independent administrative law court. OATH has two divisions that are responsible for adjudicating City matters: the OATH Trials Division and the OATH Hearings Division.

On Thursday, December 16, representatives from OATH will be at Addabbo's Howard Beach Office — located at 159-53 102nd Street — from 10 a.m. to 4 p.m. to assist constituents with any matters related to City summons they may have received.

"OATH is a vital part of City government that can help you resolve a summons issue from a number of City agencies," Addabbo said. "If you have any questions about a summons you may have received, or are curious to find out if you have an outstanding summons, then this event is right for you. OATH representatives will be at my office to assist constituents with their summons issues. I want to thank OATH for coming to my district and partnering with me on bringing their important services to my residents."

During this in-person event, OATH will assist and educate individuals about what to do should they have received a summons and can check to determine if someone has an outstanding summons. OATH staff will also provide materials for individuals on remote hearings and other free resources that are made available to the public by OATH.

The OATH Trials Division adjudicates a wide range of issues that can be referred by any City agency, board or commission. The cases it handles includes employee discipline and disability hearings for civil servants, Conflicts of Interest Board cases, proceedings related to the retention of seized vehicles by the police, Cityissued license and regulatory enforcement, real estate, zoning and loft law violations, City contract disputes and human rights violations under the City Human Rights Law.

While the OATH Hearings Division holds hearings on summonses issued by 25 different City enforcement agencies for alleged violations of law or City rules including the Departments of Buildings, Sanitation, Environmental Protection, Consumer and Worker Protection, Health and Mental Hygiene and the Taxi and Limousine Commission, among others, as well as summonses from certain non-City entities such as the Port Authority of New York and New Jersey.

All visitors to the Senator's office will be asked to wear a mask, as safety measures will be taken for their safety and others.
