#### **GEORGE JUERGENS:**

#### A Neighborhood Hero Moves on From Noguchi Museum

Far too often, changes occur in our community without acknowledgement. A building is knocked down, or the vibrant energy of a local leader is lost and the framework of the future rests upon a slightly shakier foundation. Sometimes the changes are hidden from view; however, there are those rare occasions when we are granted the opportunity to pause and take a closer look that permits us a chance to give thanks and show appreciation for those who have worked tirelessly to preserve the values that sustain community connection with dedicated effort. I am grateful to have this opportunity to shine a light on the work of Georgre Juergens, Facility Director at the Noguchi Museum as he prepares to move on to retirement.

I watched George Juergens in action on a video filmed for the museum on the occasion of the 2023 Earth Day. His quiet sense of passion and purpose is clear as he recounts the distinguished legacy of Isamu Noguchi. Juergens shared his feeling that Noguchi created the space "to set the stage for his sculptures." The role of Facilities Director evolved from this beginning and was nurtured by his fervent commitment to preservation, conservation and sustainable growth. In the spirit of Isamu Noguchi, with whom he worked, he recalls the sculptor's stated belief that "nature finishes the piece." In 2023, many years after these words were first spoken, Juergens referenced this quote to frame the ongoing evolution of the Japanese inspired garden. His stewardship attests to the fact that change has shaped and reshaped the garden with integrity and a natural push to the future. His ardent care of the garden is awe inspiring because he knows every bit of vegetation personally; and with meticulous care he has overseen decisions that link the past, present and future. For example, in the video he talked about the looming Ailanthus tree that was a centerpiece of the garden from its inception. He noted that the tree was very old and unfortunately needed to be taken down because it presented a hazard. This was not a hasty decision based on expedience, but instead a carefully considered necessity for the benefit of the whole garden that has continued to flourish with new additions and sustainable choices. The characterization of what he referred to as the naturally occurring "push-pull" underscores his knowledge, humility and deference to Nature's changes and the reality of the life-death cycle that is so evident in the garden. Here is where one can see the importance of how the community has benefited from the example of this individual and his unwavering commitment to balanced, values-based decision making.

Just when I thought that I had discovered the essence of his contribution, I was further enlightened by Eric Mathews, the former Director of Grounds at Socrates Sculpture Park, who has worked closely with Juergens over the years. Mathews highlighted how Juergens "embraced the Astoria Houses community" exhibiting true leadership in the area of community engagement. According to Mathews, he created opportunities for area youth to develop skills and engage in "dignified labor." He was instrumental in Socrates Sculpture Park receiving "two big trailers" that were used for storage and the creation of office space long before the recent construction of the current administrative building.

As George Juergens moves on to the next stage of his life, I stand with those in the community and beyond who recognize his sterling example of stewardship, leadership and scholarly regard for the historical record of one of our community's treasured cultural institutions. On behalf of us all, it is my pleasure to extend heartfelt thanks and best wishes to this community hero.





#### NEED FOR SLOWER SPEED

Greetings and happy almost summer, Woodsiders! Have you ever been riding the green wave on your bike only to have someone wearing headphones or looking at their phone, or both, step out in front of you causing you to have to veer sharply or stop suddenly? Well then you have just had a close call. I've seen

far too many of these lately, so read on for a safety PSA on how to bike in crowded and unpredictable conditions. Let's roll more carefully!

#### **Situational Awareness**

As you read this page, it may be shocking to think that you are within biking distance of tens of thousands of people. There simply is no ride in our area or our city where you will not encounter someone else on the road. Being on a bike allows you to get further faster, but the more intersections you cross, the likelier you are to encounter late crossers on foot or in cars that don't signal, and you'll need to be careful to avoid them. There is one simple way to do this: go more slowly.

#### **Proactive vs. Reactive Biking**

Having someone step out may cause a reaction, but you can control the degree of reaction by biking defensively. Almost all of our bike lanes have cyclists adjacent to parked cars or the sidewalk, so you're a step away from conflict or a door width from a collision. So if you're heading west on Queens Boulevard on the downhill towards 39th Street, don't be distracted by the sunset views and apply your brakes periodically to prevent going at a dangerous speed. Stopping while going 30mph will take close to 20ft in dry conditions, which can result in a crash or a close call, or a flip over the handlebars. Stopping while going 15mph will take around 6-8ft, which should be enough for most situations. Just because you can go faster does not mean you should!

The weather is better and biking is fun at this time of year. But whether you've been pumping in spin class or are just itching to get back on your bike, mind your speed. Expect the unexpected and plan to stop or slow down quickly. And the same goes for the densely populated part of Sunnyside and the industrial stretch west of 39th. So please bike at a reasonable speed this summer and ride safe, Woodside!




