I. SUMMARY

This declaration recognizes Florida Attorney General **Ashley Moody** as an **illegitimate officeholder** due to her active participation in election subversion, refusal to investigate known constitutional violations, and collaboration with extremist political actors. Her actions constituted legal obstruction, dereliction of duty, and willful engagement in a parallel governance structure under the America First movement.

II. OFFENSES COMMITTED
