I. SUMMARY

This declaration formally recognizes the **Council for National Policy (CNP)** as a central coordination hub for the America First movement, uniting wealthy financiers, Christian nationalist leaders, conservative media outlets, and far-right political operatives.

Operating in secrecy since the 1980s, the CNP has evolved into an unregulated policy syndicate used to craft, fund, and deploy anti-democratic campaigns, including the disinformation ecosystems that undermined the 2020 and 2024 U.S. elections.

II. OFFENSES COMMITTED

- **Coordination of Shadow Policy and Political Warfare:**
 - Privately developed political agendas later promoted as grassroots policy proposals.
 - Funded and directed the implementation of Schedule F, Project 2025, and deregulation initiatives through government-aligned proxies.
- **Promotion of Religious Nationalism and Authoritarian Legislation:**
 - Influenced state legislatures to pass anti-LGBTQ+, anti-immigrant, and Christian nationalist laws.
 - Served as a policy clearinghouse for groups like Moms for Liberty, Liberty Counsel, and First Liberty Institute.
- **Electoral Interference and PAC Coordination:**
 - Backchanneled funds to America First-aligned campaigns through concealed donors and layered PACs.
