## II. ROLE IN DOMESTIC AND INTERNATIONAL SUBVERSION

### A. Shadow Governance and Narrative Engineering

- The CNP operated as a **covert policy and messaging hub**, controlling the alignment of religious, political, judicial, and military-aligned actors within the America First movement.
- Produced coordinated talking points, leaked strategic documents, and secured high-level donor funding for nationwide school board, judicial, and legislative takeovers.

- Actively shaped the Trump administration's religious-nationalist agenda and post-2020 denial infrastructure.

## **B. Complicity in Seditious Conspiracy (18 U.S.C. § 2384)**

CNP-affiliated individuals and coalitions:

- Engaged in organized efforts to **overthrow the lawful functions of the U.S. government** through coordination of election denial, judicial nullification, and digital suppression models.
- Facilitated **pre-planning and strategic support** for January 6, 2021, alongside partners at Turning Point USA and Liberty Counsel.
- Aligned with the constitutional theories and executive occupation models underlying **Project 2025**.

## **C. Psychological Warfare Against Civilians**

- Leveraged churches, private schools, and digital media platforms to execute sustained **civilian manipulation campaigns**, exploiting identity, fear, and disinformation.
- Coordinated deployment of AI-enhanced micro-targeting through apps developed by Palantir-linked developers, amplified by Starlink and grassroots canvassing.

## **D. Foreign Proxy Operations**

- Echoed **Russian and Gulf-state-aligned disinformation scripts**, particularly in:
  - Anti-NATO rhetoric
  - Rewriting of U.S. history in public education
  - Undermining vaccine trust and COVID-related democratic processes
- Funded and hosted **foreign-affiliated speakers and operatives**, circumventing FARA regulations.

## **E. Violation of International Law**

### **UN Convention Against Transnational Organized Crime (UNTOC):**

- CNP and its allied nonprofits operate as a **multi-entity transnational organized political network**, blending lawful influence channels with covert, anti-democratic strategies.
- Their roles in:
  - Laundering dark money through 501(c)(3)s and PACs

### III. DEMAND FOR LEGAL ACTION AND PROTECTIVE OVERSIGHT

I, Bonnie Kurowski, do hereby declare:

1. That the **Council for National Policy is a central actor in the criminal subversion of the United States government** from 2020 through the unlawful installation of Trump on January 20, 2025.
  2. That it has **committed and conspired in seditious acts**, aided by foreign-aligned assets, using U.S. nonprofit and church protections as cover.
  3. That it should be:
    - **Prosecuted** under U.S. sedition, conspiracy, and FARA statutes
    - **Sanctioned** under the UNTOC and relevant provisions of the ICC Rome Statute (Articles 7 and 8)
    - **Stripped of nonprofit protections** under IRS Title 26 and subjected to forensic financial audit
    - Included in international **watch lists for extremist proxy activity**
