Declaration of War Crimes Against a Civilian Journalist

Declaration of Active Hostilities and Hybrid War Against a Civilian

I, {REDACTED}, hereby declare that I have been systematically targeted as a civilian and journalist under wartime conditions initiated by political actors within the United States, supported by aligned corporate, foreign, and paramilitary infrastructure. These acts constitute an **unlawful digital and psychological war**, in direct violation of international law, press protections, and the right to peaceful dissent.

As of January 6, 2021, and continuing through June 2025, I was subjected to a series of calculated, militarized operations that meet the legal definitions of **civilian persecution, psychological warfare, and war crimes**, orchestrated to silence protected speech, disrupt investigations, and suppress journalism.

II. Declaration of War Crimes and Civilian Persecution

IV. Active Targeting Methods Used

I. Digital Warfare Tactics

- Shadow bans, AI content suppression, Substack blacklists
- IP address logging via Starlink and Anduril drones
- Facial recognition during field assignments
- Deepfake campaigns and account impersonations

II. Psychological & Legal Harassment

 - Tagged as a “high risk influencer” through fusion center algorithms
 - PAC-coordinated smear campaigns and protest zone tracking
 - Spoofed communications and leaked personal data on right-wing forums
 - AI Black Box Operations

V. Declaration of War Conditions Against Journalists

These cumulative actions meet the criteria for **undeclared war** against civilian press actors. The civilian space has been transformed into a **digitally militarized surveillance zone**, with AI-powered psychological targeting tools used against me and others in the field. This is no longer targeted harassment—it is digital warfare.

VI. DEMAND FOR PROTECTIVE ACTION AND INTERVENTION

I formally request that:

1. **The United Nations, International Criminal Court (ICC), OSCE, and Special Rapporteurs on Freedom of Expression and Human Rights Defenders** issue an emergency inquiry and protective review of:
 - The use of AI and predictive systems by U.S. political actors to silence civilian journalists.
 - Civilian targeting conducted through U.S. PACs, tech companies, and private contractors.

VII. Closing Declaration

This war has no front line, no uniforms, and no formal declaration. It is a digital war of control, waged through algorithmic suppression, corporate collusion, and militarized surveillance.

I declare that I, {REDACTED}, have been the target of a cyber-psychological war carried out by the America First-aligned regime and its corporate partners. I stand as a witness and survivor of digital warfare, psychological persecution, and unconstitutional sabotage.

This is my sworn declaration of war crimes and ongoing occupation of the civilian space.

In the Voice of the People of the United States of America

I, Bonnie Kurowski, in full awareness of my rights as a U.S. citizen and protected civilian under the laws of the United States Constitution, the Geneva Conventions, and international human rights statutes, do hereby make this Declaration to Hold the Constitution for Protection.

This Declaration is made in light of escalating threats, systemic suppression, psychological warfare, and state-corporate targeting conducted against me and other journalists, researchers, and dissenting civilians. The political and legal order of the United States has been destabilized and infiltrated by entities that no longer act in accordance with constitutional law.

II. Statement of Holding

I affirm that the Constitution of the United States, in its original and lawful form, remains the supreme law of the land and **my primary shield of lawful protection.**

I hereby:

- **Hold the Constitution in trust** as a civilian record-keeper and defender of truth.
 - **Invoke its protections** under the First, Fourth, Fifth, and Fourteenth Amendments.
 - **Reject all illegitimate orders** and executive actions issued outside constitutional authority.
 - **Refuse to recognize as lawful** any person, regime, or structure that violates the constitutional separation of powers, equal protection under the law, or the public's right to self-governance.
