I. INTRODUCTION

This complaint is brought forth to expose and prosecute a coordinated campaign of domestic destabilization, foreign-sponsored military deployment, and crimes against humanity executed through private military contractors, financial intermediaries, and complicit state and federal actors. The complaint identifies a global conspiracy wherein **foreign governments, military contractors, and domestic political operatives** collaborated to **subvert the United States Constitution**, deploy **paramilitary suppression** programs on U.S. citizens, and commit grave violations of **international law**, including the **Rome Statute, Geneva Conventions, and domestic war powers restrictions**.

II. DEFENDANTS

A. Primary Military Contractor

- **Erik Prince** – Founder of Blackwater; executive at **Academi, Constellis, and Frontier Services Group**
- Allegations: Deployed militarized AI, drones, and private militias; drafted martial law blueprints for domestic suppression under the Trump administration.

B. Foreign State Co-Conspirators

- **United Arab Emirates (UAE)** – Provided funding and political protection to Frontier Services Group.
- **Saudi Arabia** – Directed funds via sovereign wealth intermediaries for joint enforcement programs in U.S. urban zones.
- **China (via Hong Kong)** – Provided operational cover through business partnerships with Frontier Services Group.
- **Russia** – Supplied drone tech, logistics, and intelligence cooperation via backchannel PMC agreements.

C. Domestic Political Facilitators

- **Donald J. Trump** – Received and reviewed 2025 martial law deployment plan.

- **Jared Kushner** – Acted as liaison to UAE/Saudi funding channels via Affinity Partners.
- **Michael Flynn** – Retired Lt. Gen. who coordinated the internal national security doctrine shift to allow foreign-aligned PMCs.
- **Ron DeSantis** – Alleged to have allowed PMC training and staging exercises in Florida zones.

D. Financial Intermediaries and Shell Entities

- **Frontier Services Group (Hong Kong)** – Chinese-registered conduit for foreign backing.
- **Affinity Partners (Kushner)** – Coordinated investments and real estate positioning around deployment hubs.
- **Shell LLCs in Delaware, Florida, and Nevada** – Used to launder funds from foreign nations and disguise operational funding.

III. JURISDICTION AND STANDING

This Court has jurisdiction under 18 U.S.C. § 2381–2385 (Treason, Insurrection, and Sedition), the **Alien Tort Statute (ATS)**, and international legal principles under the **Rome Statute**, recognizing crimes against humanity and foreign military interference.

IV. FACTUAL BACKGROUND

1. From 2016 onward, Erik Prince and associated companies received direct and indirect funding from UAE and Saudi sources to build **surveillance, enforcement, and military training programs**.
2. In 2020–2025, Prince actively proposed domestic enforcement plans, including migrant deportation sweeps, no-go zone clearance, and opposition suppression.
3. The Trump administration reviewed and coordinated these plans under the guise of national emergency powers and immigration enforcement.
4. Domestic field exercises occurred in:
 - **Moyock, NC** (Blackwater/Academi HQ)
 - **Southern border regions** (under guise of ICE cooperation)
 - **Urban protest zones in Oregon, Florida, and Illinois**
5. These operations violated the **Posse Comitatus Act**, **War Powers Resolution**, and international humanitarian law.

V. LEGAL CLAIMS

Count I – Treason and Sedition (18 U.S.C. §§ 2381–2384)

Count II – Conspiracy Against the United States (18 U.S.C. § 371)

Count III – War Crimes and Violations of the Rome Statute (Articles 7 & 8)

Count IV – Foreign Interference and Sovereign Subversion

Count V – Human Rights Abuses Under International Customary Law

VI. PRAYER FOR RELIEF

Plaintiff demands:

1. **Immediate asset seizure** of Academi, Constellis, Frontier Services Group, and affiliated LLCs.
 2. **Indictments** for Erik Prince, co-conspirators, and financiers.
 3. **International arrest warrants** for foreign actors complicit in war planning and financing.
 4. **Permanent injunction** banning privatized military operations on U.S. soil.
 5. Recognition that a **foreign-backed insurrection** took place between 2016–2025.
 6. **UN-backed criminal tribunal** for prosecuting state and corporate actors.
