URGENT DECLARATION OF COLLAPSE OF SUPREME COURT RULE AND CONSTITUTION

I. Title and Acknowledgment

Declaration of War: The War of Control (Present)

- Creating real-time **citizen databases** scoring loyalty, belief systems, and risk
 - **Replacing judicial process** with AI-driven targeting models
 - **Deploying robotic and drone enforcement** against dissenters
 - Turning military inward to serve private domestic regimes instead of national defense
 - Ending electoral sovereignty through behavioral suppression and surveillance

III. Methods of Control

- **AI-Driven Suppression:** Algorithms from Palantir, Anduril, Clearview AI, and Project Maven used to flag dissidents in real time.
 - **Weaponized Infrastructure:** Use of domestic military bases, FAA airspace, and Starlink satellites for behavioral mapping and elimination routing.
 - **Override of Constitutional Law:** Bypassing 4th, 5th, and 14th Amendments via emergency orders, secret court authorizations, and cyber-regulatory overlays.
 - **Predictive Kill Systems:** Drones and bots connected to Lattice OS and foreign-influenced kill-switch networks (e.g., Project Nimbus and Archveil).
 - **Behavioral Databasing:** Civilian beliefs, medical histories, internet activity, and affiliations categorized into “threat tiers.”
