Correction, Recognition, and Declaration of Multi-Domain Asymmetric Warfare:

Systemic Persecution of Journalists (2016–2025)

I hereby correct the historical and official absence of the record.

I hereby declare that a coordinated, multi-domain campaign of warfare was waged against independent journalists, media institutions, and truth-tellers in the United States and globally between January 2016 and June 2025. This war, herein titled **"The Silencing War,"** constitutes an unrecognized but fully executed operation to dismantle the free press through psychological, legal, digital, financial, and physical persecution.

This campaign qualifies as a **form of hybrid warfare and systemic persecution** under:

- Article 7 of the Rome Statute (Crimes Against Humanity persecution, enforced disappearance, political targeting);
- **Article 8 of the Rome Statute** (War Crimes unlawful targeting of journalists);
- **Geneva Convention Protocol I (Articles 51–54)** (protection of civilians and journalists in armed and non-traditional conflict);
- **International Covenant on Civil and Political Rights, Article 19** (freedom of opinion and expression);
- **Tallinn Manual 2.0, Rule 26** (prohibition of cyber attacks on civilian infrastructure, including journalistic platforms).

The goal of this war was to systematically eliminate press freedom through fear, defamation, censorship, surveillance, and forced economic, social, and legal ruin.

As a survivor and direct target of this campaign, and on behalf of many others, I submit this Declaration to ensure that this war is not left unrecorded, that its victims are acknowledged, and that its perpetrators are brought under the scrutiny of global human rights law.

The War of Subversion: January 6, 2021 – November 4, 2024

I hereby declare that from January 6, 2021, through January 20, 2025, a domestic war of subversion was waged against the constitutional government of the United States. This war was initiated and led by former U.S. President Donald J. Trump, members of the America First movement, affiliated congressional officials, foreign-aligned corporations, paramilitary actors, and technology partners.

The campaign began with the January 6 Capitol Insurrection and evolved into a sustained hybrid operation to dismantle constitutional protections and seize governmental control via unlawful and covert means.

Criminal and Legal Violations

The following actions constitute violations of U.S. and international law:

U.S. Constitutional Violations

Article II, Section 3 – Abuse of executive authority; dereliction of the duty to "faithfully execute the laws."
