 2. That **its libertarian ideology has been repurposed as a vessel for sedition**, justifying the nullification of democratic protections under “freedom” branding
 3. That **international courts, U.S. oversight bodies, and regulatory watchdogs** should assess its role in the **legal architecture of constitutional subversion**, particularly regarding privatized warfare, voting suppression, and Schedule F-style employment purges
 4. That Cato’s activities be **flagged as enabling ideological infrastructure** for the America First movement and related governance insurgencies

II. ROLE IN PROJECT 2025 AND GOVERNMENTAL SUBVERSION

1. Architect of Project 2025

The Heritage Foundation is the **lead institutional force** behind **Project 2025**, an orchestrated plan to:

- Dismantle large segments of the federal government
- Replace career civil servants with partisan loyalists
- Enact radical executive control under a unified authoritarian framework

Heritage co-authored the “**Mandate for Leadership**”, used during both the Reagan and Trump transitions, but adapted in 2023–2024 for **permanent government capture** under Schedule F and shadow government doctrines.
