I, Bonnie Kurowski, hereby declare:

1. That the **Heritage Foundation is legally and ethically complicit** in subverting constitutional governance through Project 2025
 2. That its involvement in **Schedule F, digital targeting, and political loyalty vetting** constitutes material support for government subversion
 3. That it must be referred for **investigation by international human rights bodies, the U.S. Department of Justice, and the International Criminal Court**
 4. That its **501(c)(3) tax-exempt status be suspended**, and its activities audited for coordination with unlawful occupation authorities between 2021 and 2025
 5. That its publications and personnel lists be archived as evidence of intent and operational strategy in the unlawful seizure of the United States government

2. Refusal to Uphold Election Integrity

Federalist-aligned judges in key battleground states and federal circuits:

- **Dismissed 2020 election fraud challenges**, but later **blocked voting access laws and reform efforts** brought by civil rights groups
 - Provided legal shielding for officials accused of election interference, framing challenges to GOP operatives as “political overreach”
 - Created new precedents that **weakened the Voting Rights Act**, particularly in states like Georgia, Texas, and Florida

3. Hostility to Press Freedoms and Civil Liberties

Under guidance from Federalist Society legal theory:

- Judges began ruling in favor of **executive privilege over transparency**, allowing censorship, surveillance, and retaliatory measures
 - **Anti-press decisions** expanded under Trump-aligned courts, enabling suppression of investigative outlets and whistleblowers
 - Protections for gender rights, racial justice, and immigration were **systematically rolled back** in line with “America First” nationalism

- **The judicial command center** of the America First parallel government
