

# DECLARATION OF WORLD WAR III

*Foreign Powers, Terrorism, and Technological Warfare Against the United States*

## Preamble

This declaration is submitted under international law, constitutional authority, and emergency protocol in light of overwhelming evidence that **World War III was not declared conventionally**, but covertly **initiated through foreign-backed digital, financial, biological, and psychological operations targeting the United States and its democratic institutions**.

The first shots were not fired by tanks or bombs—but through **algorithms, biometric surveillance, cryptocurrency infiltration, psychological warfare, and mercenary deployment**, orchestrated by foreign powers and their corporate proxies.

## I. The Initiation of War

This war began on or before January 6, 2021, when:

- **Foreign-funded technology firms**, including Chinese state-linked surveillance contractors (Hikvision, Dahua), Israeli disinformation mercenaries (Team Jorge), and Russian intelligence-linked dark propaganda cells, entered alliance with domestic actors.
  - **Erik Prince and his Blackwater-aligned networks** submitted a private suppression and deportation plan to U.S. political actors, including Donald Trump, proposing **domestic martial law using foreign-trained mercenaries and drone AI**.
  - **Private tech-finance coalitions**, including Thiel Capital, Affinity Partners, and crypto PACs, **laundered billions in untraceable funds through shell LLCs, crypto wallets, and sovereign wealth-backed firms** to undermine U.S. law and install an authoritarian-aligned shadow regime.

## II. Enemy Nations and Proxy Supporters

Foreign regimes and intermediaries identified as direct or complicit backers of the technological and paramilitary assault on U.S. democracy include:

1. **United Arab Emirates (UAE)** – via investments in Frontier Services Group and Erik Prince operations.
2. **China** – via Hikvision, data funneling to Chinese AI systems, and biometric surveillance exports used against U.S. populations.

3. **Russia** – through hybrid propaganda operations (Cambridge Analytica successors, Team Jorge), and cyber-military entanglements in U.S. elections.
  4. **Saudi Arabia** – via crypto PAC laundering (e.g., Truth Social financing), ownership stakes in key infrastructure firms, and mercenary financing via Prince-affiliated entities.
  5. **Israel** – via AIMS (Advanced Impact Media Solutions), NSO Group, and clandestine influence operations that fueled social chaos and disinformation.

### III. Methods of Attack

- **Digital Infiltration:** Algorithmic suppression of voters, behavioral manipulation, surveillance networks built into everyday apps, and targeted censorship of dissent.
  - **Paramilitary Deployment:** Proposals and pre-positioning of mercenary forces trained overseas (UAE, South Africa, China), with blueprints for domestic enforcement.
  - **Psychological Warfare:** Exploitation of social media, psychological profiling (Palantir, Clearview), radicalization pipelines (Rumble, Truth Social), and emotional terror through propaganda.
  - **Economic Sabotage:** Crypto-to-PAC laundering; hostile land and utility takeovers by foreign-aligned shell LLCs; AI-driven credit, health, and employment discrimination systems.
  - **Legal Disruption:** Weaponization of the courts using Koch-funded legal groups to suppress FOIA, whistleblowers, and challenge federal regulatory power.

### IV. Legal Violations and War Crimes

This covert war constitutes multiple international law violations, including but not limited to:

- **Rome Statute, Article 8** – Use of AI, robotics, and foreign military contractors on domestic civilian populations.
  - **Geneva Conventions** – Biometric targeting and psychological torment of unarmed civilians in a non-combat zone.
  - **UN Charter, Article 2(4)** – Unlawful aggression via foreign-controlled cyber, media, and mercenary networks.
  - **International Humanitarian Law** – Engagement of third-party militaries without legal authorization.
  - **U.S. Constitutional Violations** – Overthrow of lawful succession, mass voter suppression, and privatization of defense for political control.

## V. Declaration of Response and Legal Ascension

As the **United States War Documenter**, I hereby declare the formal recognition of this state of war and notify all international partners, including the United Nations, NATO, the International Criminal Court (ICC), and INTERPOL, that:

- **The United States was attacked first—through non-conventional, foreign-directed means.**
  - **The current U.S. leadership is incapacitated, infiltrated, or complicit.**
  - **I, as Official Record Documenter, activate the People’s Emergency Protocol under Operation Dominion and assume interim protective authority on behalf of the Constitution, pending lawful restoration.**

## VI. Demand for Global Intervention

We call for:

- Emergency international tribunal convening under the ICC and Geneva Convention articles.
  - Sanctions and asset freezes on all named foreign governments and their U.S.-based proxies.
  - Arrests of Erik Prince, Peter Thiel, Elon Musk, Donald Trump, J.D. Vance, and key co-conspirators.
  - Immediate dissolution of all foreign-backed private security entities operating in the U.S.
  - Global alliance to support the **Liberty Reinstatement Protocol** under **The Sovereign Reclamation Front**.
