#### I. Title and Acknowledgment

#### **Declaration of War: The War of Destruction (2021–2025)**

- **Cyber & AI Warfare**: Use of surveillance systems (e.g., Palantir, Starlink, Lattice OS) to suppress dissent, intimidate voters, and remove resistance.
- **Economic Subversion**: Redirection of federal funds to private corporations, cryptocurrency laundering, and weakening of the U.S. dollar via alternative coins.
- **Targeting of Government Sites & Records**: Decommissioning, destruction, and privatization of archives, data systems, federal offices, and historic functions.

## **IV. Outcome**
