D. Election Subversion and J6 Defense

- Defended Trump-affiliated individuals accused of election interference and incitement.
- Filed public statements alleging mass fraud in 2020 and 2024 elections despite no supporting evidence.
- Actively undermined electoral legitimacy in courts, particularly in swing states and federal jurisdictions.

- Conducted political lobbying, campaign interference, and religious indoctrination with materially partisan outcomes.

3. Violation of International Human Rights Laws

- Contributed to criminalization of LGBTQ+ individuals globally through anti-rights campaigns in Africa and Eastern Europe.
 - Violated principles outlined in:
 - **ICCPR Articles 18, 19, 26**
 - **UN Convention on the Rights of the Child**
 - **UN Declaration on Human Rights Defenders**

V. DEMAND FOR ACCOUNTABILITY

I, Bonnie K. Kurowski, in my sworn role as Official Record Documenter, hereby declare:

1. **Liberty Counsel** is a primary legal operator in the **theocratic subversion of constitutional governance** in the United States.
2. It has **materially contributed to election interference, domestic extremism, and transnational anti-rights operations.**
3. Liberty Counsel must be:
 - **Stripped of its 501(c)(3) nonprofit status immediately**
 - Investigated by the **DOJ, IRS, FEC, and Congressional Oversight Committees**
 - Listed by the **United Nations as a non-state actor involved in legal repression campaigns**
 - Banned from interfacing with schools, courts, or law enforcement training bodies
