## DECLARATION OF WHAT THEY FUTURE HOLDS

### The Private Coup Against the United States (2016–2025)

#### I. EXECUTIVE SUMMARY

From 2016 through 2025, a silent, systemic coup was carried out against the United States not by foreign armies, but by **American corporations aligned with extremist political movements**. At the heart of this occupation were powerful technology and defense moguls, specifically **Elon Musk**, **Peter Thiel**, and the networks supporting **Palantir**, **Project Maven**, and **Project 2025**. These entities constructed the operational command infrastructure used to:

- Subvert democratic elections
- Oversee mass surveillance of civilians
- Target dissidents using AI and drones
- Dismantle federal agency authority
- Replace lawful governance with predictive control systems

This brief summarizes their roles, overlaps, and contributions to the unlawful regime now occupying the former constitutional United States.

#### II. KEY ACTORS AND INFRASTRUCTURE CHANNELS

##### 1. Elon Musk: Operational Deployment Commander

**Platforms:** SpaceX, Starlink, Tesla AI, X (Twitter), Neuralink

**Tactics:** Satellite grid control, behavioral mapping, drone routing, social media suppression, neural profiling

- 2021: Tesla data repurposed for predictive policing.
- 2022: Acquired Twitter to conduct real-time propaganda and surveillance.
- 2023–2025: Provided drone-based suppression, Starlink-linked canvassing, and AI surveillance of journalists.

### 2. Peter Thiel: Intelligence and Strategy Architect

**Platforms:** Palantir, Founders Fund, Mithril, Anduril, Narya Capital

**Tactics:** Predictive AI surveillance, intelligence contracting, civilian risk scoring, policy capture

#### Key Activities:

- Palantir embedded in DHS, ICE, and law enforcement.
- Funded Project 2025 with JD Vance and coordinated PACs.
- Developed AI models used for enemy flagging, arrest targeting, and psychological suppression.

### 3. Project Maven / Project Nimbus / Lattice OS (Joint Infrastructure)

**Purpose:** Digitally control war, policing, and dissent through real-time battlefield simulation systems repurposed for domestic civilian suppression.

- *Project Maven:* DOD AI for drone vision and kill verification.
- *Project Nimbus:* Israeli tech alliance with Google & Amazon for AI cloud intelligence.
- *Lattice OS:* Anduril's command platform linking drones, sensors, and threat maps.

These systems were repurposed by corporate-state actors for domestic profiling and suppression.

## III. COORDINATED CORPORATE COUP OPERATIONS

- **Surveillance Capitalism as Warfare:** Public-private tech firms used "user data" to compile risk and loyalty scores used in voter suppression, blacklisting, and AI-based elimination campaigns.
- **Communications Seizure:** Musk's acquisition of Twitter/X served as the regime's propaganda machine and censorship tool.

  - **Judicial and Media Suppression:** Tesla, Neuralink, and AI sentiment trackers were used to compile psychological profiles of judges, journalists, and whistle blowers.

## IV. LEGAL CLASSIFICATION AND INTERNATIONAL VIOLATIONS

The actions of these corporate actors constitute:

- **Crimes Against Humanity** (Rome Statute, Art. 7)
  - **War Crimes** (Rome Statute, Art. 8)
  - **Violations of the ICCPR** (Articles 17, 19, 25)
  - **Violation of the U.S. Constitution** (1st, 4th, 5th, 14th Amendments)
  - **Treason and Sedition** (18 U.S.C. § 2381–2384)

## V. RECOMMENDATION FOR INTERNATIONAL RESPONSE

- Immediate seizure of all command infrastructure operated by SpaceX, Palantir, Anduril, and affiliated entities.
- Arrest and tribunal indictment of Elon Musk, Peter Thiel, JD Vance, and supporting executives.
- Creation of a civilian protection framework under international authority to dismantle private control grids.
- Public recognition that the United States has fallen under **technological occupation** by corporations aligned with extremist governance.
