

# DECLARATION TO REPEAL THE USA PATRIOT ACT AND THE HOMELAND SECURITY ACT

To the United States Congress, the Supreme Court, and all international legal bodies of oversight:

We, the people, now formally declare that the time has come to **repeal the USA PATRIOT Act and the Homeland Security Act** in full.

Both laws were passed in the aftermath of 9/11 under the guise of security. What they created was not safety—but a vast, unaccountable surveillance empire that eroded civil liberties, militarized domestic agencies, and legalized political persecution.

## I. THE USA PATRIOT ACT MUST BE REPEALED

The PATRIOT Act gave intelligence agencies the power to:

- Conduct warrantless wiretaps and mass surveillance on civilians
- Label dissenters as threats based on secret algorithms
- Justify predictive policing, metadata harvesting, and psychological operations
- Suppress journalists, whistleblowers, and peaceful protesters

It violated the First, Fourth, and Fourteenth Amendments of the Constitution and continues to enable unconstitutional programs run by Palantir, fusion centers, and private tech-military contractors.

## II. THE HOMELAND SECURITY ACT MUST BE REPEALED

The Homeland Security Act created:

- The Department of Homeland Security (DHS)
- Immigration and Customs Enforcement (ICE)
- Fusion centers and coordination with private militias
- A surveillance-industrial complex using facial recognition, biometric tracking, and AI flagging systems on American citizens

It allowed paramilitary forces to roam inside U.S. borders, targeting communities, journalists, and migrants as enemy combatants. It authorized **domestic terrorism under federal branding** and outsourced war crimes to contractors like **Blackwater (Academi, Constellis, Frontier Services Group)**.

These operations now function as a shadow regime—**accountable to no one, funded by everyone, and designed to suppress the people themselves.**

### **III. GROUNDS FOR REPEAL UNDER INTERNATIONAL AND DOMESTIC LAW**

The Patriot Act and Homeland Security Act both violate:

- The U.S. Constitution (Articles I, IV, VI; Amendments I, IV, V, IX, XIV)
  - The Geneva Conventions (Articles 3, 4, and 32)
  - The Rome Statute (Article 7 and Article 8 – Crimes Against Humanity and War Crimes)
  - UN Universal Declaration of Human Rights (Articles 9, 12, 19, and 21)

### **IV. DEMAND FOR IMMEDIATE ACTION**

We therefore demand:

1. The **full and immediate repeal** of the USA PATRIOT Act.
  2. The **full and immediate repeal** of the Homeland Security Act of 2002.
  3. The **disbanding of DHS and ICE** and all derivative agencies built from these acts.
  4. The **defunding and closure of all fusion centers** and AI-based civilian surveillance programs.
  5. The **prosecution of officials and contractors** who used these acts to carry out unlawful targeting, detentions, and surveillance.

### **V. FINAL WARNING TO THE REGIME**

The continuation of these laws constitutes a **clear and ongoing crime against the American people and against humanity**. You cannot silence the people you swore to protect. The people have risen. The people now see.

This is not a protest. This is a declaration of lawful reversal, backed by truth, law, and moral obligation.

Repeal the acts. Dismantle the regime. Return power to the Constitution, or stand accountable before the world.

# ***I DECLARE THE ADOPTION OF THE PEOPLE'S ACT***

**A Bill for the Repeal of the USA PATRIOT Act and the Homeland Security Act**

## **SECTION 1. SHORT TITLE**

This Act may be cited as "**The People's Act to Restore Constitutional Rights and Civil Liberties.**"

---

## **SECTION 2. REPEAL OF THE USA PATRIOT ACT**

**(a)** The USA PATRIOT Act (Public Law 107–56), signed into law on October 26, 2001, and all subsequent amendments and extensions are hereby **repealed in full**.

**(b)** All provisions that allow for:

- Mass surveillance of U.S. citizens or foreign nationals without individualized warrants
- Collection of phone records, internet metadata, or location data without due process
- Secret court proceedings under the Foreign Intelligence Surveillance Act (FISA)
- Classification of political dissent as "domestic terrorism"

...are declared **unconstitutional** and **null and void**.

---

## **SECTION 3. REPEAL OF THE HOMELAND SECURITY ACT**

**(a)** The Homeland Security Act of 2002 (Public Law 107–296) is hereby **repealed in its entirety**.

**(b)** All agencies created or authorized by this Act, including:

- The Department of Homeland Security (DHS)
- Immigration and Customs Enforcement (ICE)
- The Federal Protective Service (FPS)
- All federal fusion centers

...are hereby **dismantled** and **defunded** within 180 days of passage.

---

## **SECTION 4. TERMINATION OF FEDERAL SURVEILLANCE CONTRACTS**

All existing contracts between the federal government and private surveillance vendors—including, but not limited to:

- Palantir Technologies
- Anduril Industries
- Clearview AI
- Blackwater-aligned private contractors
- Fusion center data aggregators
- Biometric and predictive algorithm providers

...shall be terminated and permanently barred from renewal or rebidding.

---

## **SECTION 5. RESTORATION OF CIVIL LIBERTIES**

**(a)** The rights guaranteed under the U.S. Constitution—including but not limited to the First, Fourth, Fifth, Ninth, and Fourteenth Amendments—shall be immediately restored and prioritized above any executive or intelligence directive.

**(b)** All data collected under repealed programs shall be:

- Expunged from federal systems
  - Made available to impacted individuals upon request
  - Subject to independent civilian audit and destruction orders
- 

## **SECTION 6. INVESTIGATION AND ACCOUNTABILITY**

**(a)** A Special Independent Commission shall be established to investigate:

- All human rights abuses committed under the authority of the repealed acts
- The misuse of federal surveillance and domestic force
- Contract fraud and misuse of appropriated funds

**(b)** Criminal charges shall be pursued against individuals and entities found to have participated in:

- Unlawful targeting
  - Warrantless surveillance
  - Covert influence operations against the U.S. population
- 

## **SECTION 7. INTERNATIONAL COMPLIANCE**

This Act shall bring the United States into renewed compliance with:

- The Geneva Conventions

- The Universal Declaration of Human Rights
  - The Rome Statute of the International Criminal Court
  - United Nations General Assembly Resolution 217 A
- 

## **SECTION 8. EMERGENCY IMPLEMENTATION**

This Act is deemed necessary for the preservation of liberty, the restoration of constitutional order, and the prevention of further harm to civilians.

**It shall take effect immediately upon passage.**
