I. ENTITY IDENTIFICATION

Name: Alliance Defending Freedom (ADF)

Legal Classification: 501(c)(3) Nonprofit Religious Legal Organization

Founded: 1994 (originally as Alliance Defense Fund)

II. MISSION PROFILE

ADF describes itself as a legal advocacy group defending “religious liberty, free speech, marriage and family, parental rights, and the sanctity of life.” However, public records, court filings, and affiliated campaigns indicate that ADF:

- Functions as the **primary litigation and legislative engine** for Christian nationalist movements.
 - Plays a **central role in legal warfare against democratic institutions**, LGBTQ+ rights, women’s rights, and public education.
 - **Coordinates globally** with authoritarian-leaning religious regimes and institutions.

III. KEY AFFILIATIONS

ADF maintains direct and strategic ties with:

- **The Council for National Policy (CNP)** – board overlap and aligned campaign strategy
- **The Federalist Society** – shared judicial vetting goals
- **The Heritage Foundation** – co-contributors to Project 2025 policies

IV. COMPLICITY IN CONSTITUTIONAL SUBVERSION AND HUMAN RIGHTS VIOLATIONS

A. Judicial Capture

- ADF attorneys actively groomed and promoted judicial candidates who ultimately served to:
 - Overturn *Roe v. Wade*
 - Weaken LGBTQ+ and civil rights protections
 - Roll back voting rights and Title IX enforcement
- Participated in coordinated efforts to **flood courts with religiously-aligned legal reasoning** that nullified federal safeguards.

B. Election Interference

- Operated as a legal firewall for **election denial lawsuits post-2020**, providing briefs, counsel, and public media spin to justify false claims of fraud.
- Participated in disinformation campaigns tied to *Stop the Steal* through shadow affiliates.

C. Global Theocratic Expansion

- Partnered with international networks to:
 - Criminalize LGBTQ+ behavior abroad
 - Impose U.S.-modeled anti-abortion laws in Eastern Europe and Africa
 - Undermine UN conventions on civil and human rights

D. Violation of International Human Rights Law

- Engaged in coordinated suppression of:
 - Women's bodily autonomy (CEDAW violations)

V. DEMAND FOR ACCOUNTABILITY

I, Bonnie K. Kurowski, acting in my role as Official Record Documenter, do hereby declare:

1. That **Alliance Defending Freedom (ADF)** is no longer a lawful nonprofit religious entity, but a **domestic and international political agent engaged in religious extremism, psychological warfare, and civil subversion.**
 2. That ADF has **directly supported or enabled human rights violations** through its legal work and partnerships.
 3. That ADF should be:
 - **Stripped of 501(c)(3) tax-exempt status**
 - **Investigated for sedition and material support to subversive campaigns**
 - **Banned from participation in international human rights negotiations or U.S. judicial candidate preparation**
 - **Listed by the United Nations, European Union, and ICC** as an extremist actor operating under civil society disguise
 - **Included in Congressional Oversight and Judicial Ethics Review panels** post-occupation
