II. Summary of Weaponized Use Under Occupation

The 2025–2025 invocation enabled:

- **Targeting of lawful U.S. citizens and residents** by classifying them as “enemies” based on AI prediction models, ideology, religion, or digital behavior.
- **Secret data-based tribunals and removal orders**, with no public process, transparency, or due process.
- **Digital and psychological warfare**, including social erasure, flagging, de-banking, and denial of housing or services.
- **Military-grade surveillance and drone enforcement**, often outsourced to private defense contractors.
- **Flagging of dissidents**, journalists, immigrants, and protest organizers as “threat actors,” despite no criminal action.

These actions were performed **under the framework of a modern occupation**, where public offices remained intact, but constitutional control had been lost.

III. Violations of Law

The invocation of the Alien Enemies Act under these conditions violated:

- **U.S. Constitution**
 - **1st Amendment** – Free speech, religion, press
 - **4th Amendment** – Right against unreasonable searches and seizures
