

**IT IS DECLARED THAT DONALD TRUMP IS ILLEGITIMATE, UNITED STATES
CONSTITUTIONAL STAND-DOWN ORDER
SECOND NOTICE TO ALL MILITARY COMMANDERS AND PERSONNEL**

SUBJECT:

Stand Down from Unlawful Orders by Donald J. Trump — Uphold Your Oath to the United States Constitution

NOTICE:

Donald Trump is an Occupier. He was informed yesterday to **NOT GIVE ANY MILITARY ORDERS**. Today his team is trying to stop the Citizens from rising against in Illegitimate President who WILL NOT stop Occupying and giving unlawful orders.

Article II, Section 2 – U.S. Constitution

“The President shall be Commander in Chief of the Army and Navy of the United States... when called into the actual Service of the United States.”

Interpretation:

This power is not absolute. It is limited by the Constitution and the authority granted by Congress. If Donald Trump is no longer lawfully president, then he cannot exercise this power.

He cannot:

- **Command the military without lawful office.**
- **Use military force to suppress lawful civilian dissent.**
- **Assume emergency powers beyond constitutional limits.**

I Invoke the Constitution and U.S. Military Oaths

“The military is bound to defend the Constitution, not a person.” Refer to **Article II, Section 2** and **10 U.S. Code § 333** (restraining unlawful domestic deployment).

10 U.S. Code § 333 – Assistance to enforce Federal authority

“The President may employ the armed forces... to suppress, in a State, any insurrection, domestic violence, unlawful combination, or conspiracy, if—

- *(1) it so hinders the execution of the laws... that any part or class of its people is deprived of a right, privilege, immunity, or protection named in the Constitution; and*
- *(2) the constituted authorities of that State are unable, fail, or refuse to protect that right.”*

Interpretation:

This law does not grant blanket power to use military force. It only applies when:

- A state is unable or unwilling to protect constitutional rights, AND
- Congressional authority and constitutional process are still intact.

If the federal government is itself illegitimate or acting in violation of the Constitution, then this code cannot be invoked lawfully by the occupier.

This is who paid him.

You are Ordered to Cease and Desist Unlawful Orders

We demand Demand for Adherence to Oath to the Constitution, not the Executive

Under Article II, Section 2 of the U.S. Constitution and 10 U.S. Code § 333, the authority to command the military exists only if the president holds lawful office and only to protect, not suppress constitutional rights. Donald J. Trump, having been declared illegitimate and acting outside of constitutional succession, holds no such authority. Any order issued under his name for domestic military deployment is void, unlawful, and must be refused.

This is the second time You are hereby notified that:

1. **Donald J. Trump has been declared illegitimate** under the United States Constitution due to:
 - The overthrow of constitutional succession on January 20, 2025.
 - His unlawful continuation in power through fraud, military coercion, and AI-assisted election subversion.
 - The deployment of military force against unarmed civilians without constitutional or congressional authority.
2. Your **oath is to the Constitution**, not to any one man, party, or executive figure. The Constitution remains the supreme law of the land.
3. You are **duty-bound under the Uniform Code of Military Justice (UCMJ)** and Geneva Convention to **refuse unlawful orders**.

UCMJ Articles 90–92 affirm that **only lawful orders** must be followed.

Article 7 and Article 8 of the Rome Statute prohibit the use of military force against civilian populations under unlawful authority.

4. Under **10 U.S. Code § 333**, the U.S. military may not be used to suppress lawful assembly or dissent.

ORDER:

Effective immediately, you are to:

- **Stand down** from any order issued by Donald J. Trump or his agents to act against the civilian population, including protestors, journalists, public officials, and legal recorders.
 - **Report and document** any such orders through your JAG channels and to the International Criminal Court if necessary.
 - **Uphold your oath** to defend the United States Constitution from **all enemies, foreign and domestic**.
 - **Assist the restoration of lawful government**, and protect civilians from unjust force.

FAILURE TO COMPLY:

Failure to disobey unlawful orders may result in:

- Criminal liability under UCMJ for war crimes.
 - Inclusion in international war crimes investigations.
 - Dishonorable discharge and forfeiture of pension or protections.
 - Moral betrayal of the United States and its founding principles.
