

Privacy Policy

This Privacy Policy ("Policy") applies to [www.http://onceuponacabintahoe.com](http://onceuponacabintahoe.com), and Big Blue Sky LLC ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include [www.http://onceuponacabintahoe.com](http://onceuponacabintahoe.com) and Once Upon a Cabin Tahoe. By using the Company website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- First and last name
- Mailing address
- Email address
- Phone number

If you purchase the Company's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Sharing Information with Third Parties
