**PETITION OF FORMATION
IMPROVEMENT AND SERVICE DISTRICT**

Come now the undersigned persons, acting pursuant to Wyoming Statute 18-12-106 and 107 pertaining to the petition of formation for an improvement and service district, and represents as follows:

1. That the signatures of not less than sixty percent (60%) of the persons owning land within the territory proposed to be included in the district, whose land in the proposed district has an assessed value of sixty percent (60%) or more of the assessed value of all the land within the proposed district are attached to this petition of formation.
2. That the proposed name of the district is Redstone Upper Green River Service District.
3. That the boundaries of the district and the land situated therein are described as follows: Lots 1-36 of the Redstone Upper Green River Subdivision as recorded in the office of the County Clerk of Sublette County, WY, in Book 29 Miscellaneous Records, page 83 and page 356; lots 1-2 of Elk Ridge Lot Subdivision as recorded in the office of the County Clerk of Sublette County, WY, in Book 52 Miscellaneous Records, page 405; and the Harris property consisting of ten acres in Township 38N, Range 110W, Section 26, a tract in SE ¼ of the SW ¼ as recorded in the office of the County Clerk of Sublette County, WY, in Book 35 of Deeds, page 327.
4. That we hereby request that a district be formed under this act.
5. That the improvements proposed to be acquired or constructed and operated and the services to inhabitants of the district are described as follow: Maintenance of roads and bridges, perimeter fences, and other common areas as needed.
6. That the proposed method for financing the improvements or services are detailed as follows: Taxes will be levied according to the appraised value of property, and held in an interest drawing account until needed. The projected annual cost of road and perimeter fence maintenance as well as the projected cost of bridge repair will determine the amount of the taxes, not to exceed 8 mills, when needed. Adjustments in the mill levy will be made annually, according to need.
7. That the names of the three (3) persons or the commissioners nominated to serve as the initial board of directors of the district are as follows: John Anderson to serve as the three (3) year board member; Catherine Summerall to serve as the two (2) year board member; and Patricia Negus to serve as the one (1) year board member.
8. A committee of three chief petitioners who shall represent all petitions and subscribers in matters relating to this petition of formation are the following:
