1. Call to Order

2. Previous Minutes.....July 20, 2026

Motion to approve July minutes passed. Lillian motioned, Louise seconded.

3. Barbara O'Neil's Resignation as Treasurer - effective August 8 for the remainder of her term.

Catherine had asked her twice to reconsider. The Board accepts, regrettably.

4. Board Appointment of New Treasurer

Board must appoint a new Treasurer. Barbara D. and Catherine P. spoke with Sandi Harper, past Treasurer, who is willing to take over through 2027. Robin motioned and Lillian seconded. Sandi Harper appointed. Barb & Catherine subsequently spoke with Sandi and informed her that she was appointed by the Board to fulfill the remainder of Barbara O'Neil's term. Catherine spoke with Barbara O to tell her that Sandi would succeed her. We set up an appointment to meet Tuesday, Aug. 25 to get the records from Barbara O. and transition to Sandi. All will then go to the bank (maybe within a week or so) to get Barbara O off the account and add Sandi.

5. Financial Report - C. Parente -- with no report from Barb O., Catherine reported...as a signatory she will be taking over in the interim. Since Sandi is not new to the position, it should be a smooth transition. The Ryder will be worked through the Men's Inner Club. Catherine and Barb D feel fairly comfortable with where things are currently. From last month's checkbook balance, there was the PayPal cash receipt from one member for the M/G tournament. There were also two checks made out to refund Deb Fera (\$200) and Darlene Skorski (\$175). Darlene's check cleared on Aug 8; Deb's check has not yet cleared. Current checkbook balance is \$8,570.28 (last month's balance of \$8,687.23 minus \$200, minus \$175, plus the \$258.05). The bank balance is \$8,815.28 less two outstanding checks totaling \$245, which equals \$8,570.28.

6. Unfinished Business

a. Club Championship - C. Parente – everything moving forward. Finalists are set in each bracket. Catherine will confer with Lori F. regarding prizes/engraving.

b. Nominating Committee - L. Thornton – Pam/Dawn/Nancy reported they have two names of people willing to run for Governor (Sue R and Rachel P), Secretary considering another term, and they were reaching out to some people for President. Discussion regarding possible candidates and desire for continuity. Barb D. encourages people to consider sharing the presidency as well. Louise will speak with Pam/Nancy about this idea.

c. Privacy Screen - C. Parente – All is ready to go, with the plan for the bulk of the info to be put in the private section. Upon reflection, Catherine P/Barb D thought it might be better to do this at the beginning of next season, incorporating on membership/registration process, rather than potential confusion for the remainder of this year. Catherine would be happy to work on getting things in place with Pam for next season, if needed.

d. Member/Guest Update -- Member guest report – all who attended reported that it was a great event and well run. Tracy H. and Cheryl J. did a wonderful job. Final report given. Event expenses came in under budget, including the \$500 allocated by the Club. \$5526.05 collected / \$5721.91 spent (net expense over income just \$195.86)

e. Team Matches Update - R. Gershkoff -- This year has been quite unorganized with lots of confusion. Pretty much all-consuming for Robin over the past month with all the last-minute schedule changes and disarray. Teams/clubs had conflicts despite the match dates being known early and Katie needed to beg teams to play. Tomorrow (Aug 25) Triggs is hosting/playing in the Fernald Cup and also playing in the Baker Bowl at Agawam.

f. Social Media - K. Riquinha – Kathye had sent link from Robin Sisti. Kathye also spoke with Despina and she agreed to manage the social media next year. LuAnn is good at taking pics, but doesn't want to post. Maybe she/others can share pics with Despina to post.

g. Pace of Play email of July 28 – Barb D. asked for any feedback. Tonia reported hearing from a few who thought it was good and appreciated getting it. Overall, we have had only a couple issues through the season.
