**Treasurer’s Report**

- Barb O. e-mailed copies of the Treasurer’s report as of June 21 to all Board members. **New Business**

- Club Championship update: Catherine reported that she & Lori will be putting all the brackets together and announcing this coming week. Btw 10 – 14 opted out. A question came up from a member as to her eligibility since she wasn’t able to play a lot last year, other than in 3 weeklies and 2 club championship rounds, and this year only one event. Upon checking the specificity of the language re: the requirement to play “5 events in previous year” and “2 events in current year prior to CC,” the Board determined that since we don’t have definitive language around what qualifies as an event, we should allow her to be eligible this year. It was decided to ask the By-laws committee to revisit and clarify this language during its work this year.

**Other Business**

- In other business discussed, the issue of the time change on June 15 was explained. It was due to fewer men than anticipated signing up and the women’s times got moved up without letting Barbara D know. Nothing really to be done, as even if we had known, it likely would have been too late to offer times to additional women.

**Treasurer’s Report**

- The member guest tournament chaired by Tracy Higgins and Despina Metakos was held on July 20. The event was considered a success – well run, well attended, and good food. Recall that it was agreed that the members who ran the tournament would have their and their guests’ fees comped. Tracy and Despina generously donated their guests’ comped fees, by making a cash donation of \$254 to be paid out for net skins prizes. In addition, Karl/the pro shop provide certain discount fees resulting in \$189 savings. Overall, the tournament resulted in a \$201 net cost to the club.  
--A motion to approve the Treasurer’s report/budget, Alexandra C. and Robin G. 2<sup>nd</sup>, passed.

**New Business**

- Proposed Changes to the By-Laws

The By-Laws committee members in attendance (Louise Thornton, and Lori Fredericks) reported on their meeting/discussion of two proposed changes to the By-Laws. These are:

(1) a change to Article II, with a new Section 7 (Board of Governors) that would allow for voting in advance of the annual meeting. Essentially, the proposal would allow for emailed votes to be sent to the Nominating/Elections Committee by those members who are unable to attend the annual membership meeting, or who wish to vote in advance; and

(2) a change to Article V (Membership) that would specify the requirements a member must meet to play in the Club Championship. The proposal would define the term “event” (in the requirement to have played in five “events” from the previous year, or two “events” prior the Club Championship) to mean weekly tournament and majors.

For both of these proposals, the Board discussed some edits and more specific wording, including identifying that the Nominating Committee would be renamed the “Nominating/Elections



Committee,” with the additional role of overseeing the annual election. These changes will be finalized and proposed in time for discussion at the next Board Meeting in August.

- Membership-Wide Communications About Outside Events

An issue has arisen regarding how members might be able to provide information to the entire membership about certain types of outside events. The Board discussed whether we want to allow for this, and whether we could do this through mass email to the membership, and/or through the creation of a separate webpage on the website that is specifically designated for that purpose. The Board agreed that we did not want to allow the use of a mass email, but that we would agree to create a separate section on our website for these types of communications. The types of communication will be limited to charitable or other golf related events only. If the Website Master has a question about whether any submitted communication meets the above criteria, she shall submit that communication to a Board member for review and approval prior to it being posted. The designated webpage will be entitled, “External Golf Related Events,” and an email notification about its creation will be sent to the membership.

#### **Unfinished Business .**

- Barbara O’Neil noted that there had been an inquiry about starting back up the tournament with Fall River (and other clubs, potentially) that we have referred to as the “Fall River Challenge.” Pam Brodeur made a call to a contact at Fall River, but never had any response back.

Motion to approve July minutes –Robin G, Lilian 2<sup>nd</sup>. Motion passed.

**Treasurer's Report**

- Barb O reported a balance of \$7,680.17. The check for \$544 to the Clubhouse for the Red & Blue tournament is outstanding, but expected to be cashed tomorrow. Barb questioned whether we are having a Ryder Club this year. After discussion, the Board recognized that we will be fulfilling our 6 majors this year, including the upcoming end of season; however, Pam has agreed to help run the Ryder Cup this year since Tracy will be out of town. The date is October 4 and that date has been confirmed with Karl. No Ladies Inner Club funds will be used for this tournament. It will have entry fees, which will cover the expenses and the men will run it (per Pam). The date has subsequently been changed to Oct. 5 per a message from Pam.
- Barb O and Catherine brought up the issue of the Treasurer having to use her personal SS# for banking and the plan for getting a Tax ID so that going forward our Treasurers will not have to use personal information. We will still have to change signatory. Catherine will apply for a Tax ID for the club.

**Club Championship Update**

- Catherine reported that all seems to be going well and that all groups are in their final rounds. Also, she noted that many matches have been played during the week rather than on the weekends.

**Website Posting of other golf events**

- The new web page is up with multiple notices. The Board agreed that the message that had gone out earlier to members was notice enough, but that we could add a note about the new page's existence to beginning of season announcements. There also was discussion about the direct solicitation last week at the course in connection to one of the postings, the Wish Come True Masters raffle. Barb O voiced objection to this, but all recognized that it would be difficult to stop it from happening.

**By-Laws Changes Review & Discussion**

- On behalf of the By-Laws committee, Louise Thornton reported on their meeting/discussion of suggested updates to the By-Laws beyond the initial edits/changes that were presented last month.
  - (1) There was further discussion on the issue of requiring that 3 events vs. 2 be played in a current year to allow participation in the Club Championship. This would ensure that anyone new to the club would need to make a significant commitment before being able to play in the Club Championship. After discussion, the Board voted on this further change to the updated language.
  - (2) There was further discussion about the creation of a Nominating/Election Committee and language delineating some changes to the prior proposed will be incorporated in the By-Laws
  - (3) Louise reviewed further edits throughout that the committee had recommended after going through the entire document to clean up and make language more consistent. Barb O and Catherine offered additional recommendations not caught.
  - (4) Additional specific sections were discussed including wording regarding how the financial report will be made available to any member upon request, whether we should eliminate the section mentioning the club is open to all players regardless of race, creed, etc., and whether we should address the issue of sex
  - (5) There was also discussion about the existing language around Tournament committee/chair and edits to better reflect current practice.
- Louise was going to get in touch with the By-Laws committee quickly to try to have a final meeting to work on these further edits/updates so they can be reviewed one last time by the Board before they are presented to the membership. They need to be presented 30 days prior to the annual meeting. The plan would be for the Board to have a Zoom meeting next Monday or Tuesday, August 25 or 26.

### **New Business**

- Barb D. discussed the idea of post-season play, separate from the regular season. The group was receptive to trying a less formal play format for anyone who is interested, with tee-times being offered and sign up procedure being the same. Barb is going to look into this with Karl.
- Catherine brought up for discussion whether the club should consider getting a business Venmo account. Unlike personal Venmo accounts, there would be fees associated with transactions. After discussion, the decision was to table it for now.
- Alex raised a point brought to her attention from a new member who was unable to play in the Red vs. Blue tournament due to not being able to find a partner. While it tends to happen informally, the Board discussed the old practice of having mentors/"buddy system" for new members as a way of onboarding new folks and helping them get introduced to everyone and everything as a possible way to help this from happening in the future.
