**1. Call to Order**

**2. Previous Minutes.....May 19, 2026**

Motion to formally approve May minutes passed. Robin motioned, Lillian seconded.

**3. Financial Report.....B. O'Neil**

Barb O. sent a report to the Board on June 13. Balance - 9,243.19. Two bills paid since last, Red vs. Blue and annual GHIN to Men's Inner Club. Next will be for Member/Member event.

**4. Unfinished Business**

**a. Club Championship** – Opt-out date was June 15. Lori and Catherine will check to see if everyone who is in is eligible.

**b. Member/Member update...** Sign-up underway

**c. Nominating Committee** - Louise is acting as liaison to ensure the new nominating process/duties and communications with committee and membership. Louise asked if she should just approach people individually or send an email to elicit general interest in joining committee. Group thinks it would be a good thing to send an email to the membership citing the new process, etc.

**d. Social media update** - Kathye was to reach out to Robyn Sisti and did so during the meeting. Barbara O. said she was involved in the creation of the Facebook page and at one time had the password, but no longer has it. Kathye heard back from Robyn, who said she will get back in touch soon with the password info she has.

**e. Member/Guest.....August 22 - T. Higgins has agreed to run.**

Discussion around Board's contribution – Barb O. recounted that in past we would have a budget. Proposed \$500. Split the pot could be run to add to the \$500. Agreed we should approach Tracy regarding running a split the pot to help underwrite.

**f. Update on Privacy Screen/implementation** – it is all set up on website; we need to decide what items we want behind the privacy screen, basically everything except basic non-personal/league info. Each member will need to be assigned a profile and set up their own password. Barb D. will get back with Catherine/Pam re: full implementation process and next steps.

**g. Ditch on Hole 6/7 and other course conditions**

Robin brought up the conditions on the 12<sup>th</sup> hole where trees were removed and there being mulch, etc., as well as on hole 15, where the new sod has been put...there are some seam holes. Barb D. also had discussed the ditch between hole 6 and 7 getting free relief. The Men's Inner Club and RIGA, for all of their events, both consider this ditch free lift and she thinks we should do the same. Barb will check about the 15<sup>th</sup> hole as far as when we can expect that area to be complete. Board agrees we should adopt the free lift option used by the men...only if/once ball is found in the ditch.

Since there have been varied and ongoing issues with all the course improvements underway and in that we have a number of new members this year, Barb O. (in her capacity as Rules Committee Chair) will craft a message to the membership reminding everyone about standing rules and about instances where relief is possible and other basic practices for playing where there is ground under repair.
