Treasurer's Report

Membership and Paypal update

- Barb O. reported our balance (\$12,655.19). New report sent. No outstanding deposits. Received payment from 49 members, waiting for two returning member payments. With 11 new members, we anticipate 51 total. Three members did not renew...Elaine Akaka, Lisa Kaminski, Jayne Graham. Once we get all payments, Barb O. will send the membership list out to members with note about keeping people's info private.
- Deduction for PayPal fee of \$7.69 (refund for testing) to establish the Club as a business account. There is a 3% fee taken on paid amounts, so we are adding 3% to fee for anyone wanting to use PayPal for payments... One person (Deb Fera) used PayPal for membership. Catherine reported that she thinks that in the future PayPal may have a way to link to Venmo...she will watch for more info on that.
- Meet & Greet was a successful event, enjoyed by all, despite some who said they were coming but didn't and others who did not reply but came. Several new members attended. Food was good.
