ELFM will use the personal information we collected in this application to assess your spiritual, academic, emotional and relational qualities for credential in ministry. ELFM will not use your personal information for any other purpose without first seeking your consent, unless authorized or required by law.

After all questions have been fully answered, this application should be returned to our Central Office. This, along with any other application forms must be received before an interview will be scheduled with the Apostolic Council Credentials Review Committee (CRC).

All paperwork submitted becomes the property of ELFM No paperwork submitted will be returned to you!

Make copies of all paperwork to be submitted.

- ❖ Enclose 2 current pictures of yourself (head shot and full length) and any letters of recommendation from Christian Leaders/Pastors who know you and your ministry in an addendum separately.
- ❖ Enclose a typed personal testimony and statement of basic doctrinal beliefs: salvation, baptism, Holy Spirit's role in the believer's life, etc. This statement should be submitted in (APA) standard college level essay format. Ten pages (including title and reference pages).
- ❖ Include all references and citations.

#### ETERNAL LIFE FELLOWSHIP MINISTRIES

Christians have practiced ordination since New Testament times. In different eras, and in different churches, it has assumed different characteristics. ELFM practices ordination as a formal dedication of a person to a particular ministry. It is ordination to a task, with the blessings of the church. It is done in confirmation of the inward call of God, which the ordained professes, and it affirms trust in them as one who will faithfully serve Christ. Since ordination is for life, and may in time involve the life and work of several congregations and the reputation of the Church of Jesus Christ, haste should be avoided in calling anyone to ordination. However, it is appropriate for the local church to do so when they believe a disciple has demonstrated the call of God to the diaconate or the pastoral ministry.

The church issuing a call to ordination of a candidate for ministry has the responsibility to consider the candidate's sincerity, faith, doctrinal understanding, morality, ability and training for gospel ministries. This process involves considerable preparation and a number of steps, but the act itself consists of a simple, but solemn and prayerful, and the laying on of hands. An ancient symbolic gesture indicating the bestowal of trust, the New Testament church in setting apart Christian servants practiced the laying on of hands. This is a very personal act, in which representatives of God's people prays for, pours oil on the head and lays hands on the candidate, ordination in ELFM is usually performed by all of the ministers present, including those from other denominations. It is done with authority of apostolic succession. The act of ordination is functional, not sacramental.

The authority for licensure and/or ordination lies in the local church congregation. It is the local church congregation which calls one of its members to service and leadership. It is the congregation which recommends licensure and/or ordination. However, each local church has a responsibility, not only to the candidate and to itself, but also to the entire ELFM organization (and to the Christian world in general) to act responsibly and in the true spirit of the New Testament precedent.

The consecration of an Apostle in the modern church is a highly sacred and ceremonial event, often unique to each denomination and/or tradition. The process varies depending on theological perspectives, liturgical practices, and ecclesiastical structures. Below is the generalized procedure for sanctification and affirmation an Apostle in Eternal Life Fellowship Ministries, incorporating traditional elements along with contemporary practices:

#### Procedure for the sanctification and affirmation an Apostle in Eternal Life Fellowship Ministries

#### 1. Preparation

#### • Spiritual Preparation:

- o The candidate being consecrated as an apostle should undergo a period of prayer, fasting, and spiritual discernment and extensive biblical doctrine training. This may last from a several months to few years, depending on the candidate's education and/or experience.
- o The candidate should be examined for their qualifications, including their calling, character, and understanding of Scripture and Doctrine of ELFM.
- The Apostolic Council should meet to discuss the candidate's fitness for the role. This may include an evaluation of the candidate's experience in ministry, gifts of the Spirit, and ability to lead others.

#### Public Announcement:

- Prior to the affirmation, the church may announce the upcoming event to the congregation, inviting prayer and support from the community.
- o In some cases, a special retreat or series of teachings may be offered to prepare the church body for the significance of the affirmation.

#### 2. Gathering of the Body

#### • Venue and Setting:

o The affirmation typically takes place in a church setting, such as the main sanctuary or another appropriate venue, and is often accompanied by a worship service. The atmosphere should be reverent, with sacred music, prayer, and Scripture readings.

#### The Conclave:

A private meeting of the Apostolic Council to affirm a new Apostle. The Apostles designated in this role are known as board of electors and must be an active Apostolic Council member, within 24-48 hours prior to the ceremony, the board of electors takes an oath of confidentiality and the meeting is sealed. The Candidate is interviewed and questioned concerning biblical truths and doctrine of Eternal Life Fellowship Ministries. The word "conclave" comes from the Latin cum clave, which means "with a key".

#### Participants:

- Senior fellowship leaders lead the affirmation from the Apostolic Council with recommendations from the Board of Bishops, or other high-ranking clergy. These individuals should have the authority within the tradition to affirm apostles with the rite of Apostolic Succession.
- o The congregation, including family and friends of the candidate, will also be present to witness the event.
- o The candidate may be surrounded by other apostles, prophets, or ordained ministers who will lay hands on them during the ceremony.

#### 3. The Ritual of Affirmation

#### Opening Worship:

o The service may begin with a time of worship, hymns, and prayers, focusing on the glory of God and the significance of the Apostolic gifted office.

#### • Scripture Reading and Reflection:

- A passage from Scripture is read to establish the biblical foundation for the apostolic office.
   Common texts may include:
  - Ephesians 4:11-13 (God's gift of apostles, prophets, evangelists, pastors, and teachers).
  - Acts 1:15-26 (The selection of Matthias as an apostle).
  - 1 Corinthians 12:28 (God's order and gifts for the church).
- A senior leader may deliver a brief reflection on the role and responsibility of an Apostle.

#### Oath of Commitment:

- The candidate makes a public declaration of commitment, often stating their willingness to serve the church and the Lord in the apostolic role. This may include a vow of loyalty to Christ, obedience to God's calling, and a promise to uphold the church's teachings and mission.
- The candidate may also pledge to live a life of integrity, humility, and service, recognizing the weight of the apostolic responsibility.

#### • Laying on of Hands:

- The laying on of hands is a central element of the affirmation. Senior leaders, often members of the Apostolic Council and visiting leaders place their hands on the candidate's head and shoulders as a symbol of the transfer of authority, power, and blessing.
- o This will be accompanied by prayers for the candidate's empowerment by the Holy Spirit.
- This moment is marked by a powerful prayer asking for divine guidance, wisdom, and strength for the new apostle to carry out their duties faithfully.

#### Anointing with Oil:

- o The candidate is anointed with consecrated oil. This act symbolizes the filling of the Holy Spirit, marking the candidate as set apart for the apostolic ministry.
- o A senior leader may perform the anointing, and the oil may be applied on the forehead or hands, depending on tradition.

#### 4. Apostolic Charge

#### Mandate

- The senior leader or bishop gives a formal charge to the newly consecrated apostle. This charge may include specific instructions, such as:
  - The Apostle's responsibility to establish and oversee churches, ministries, and leaders
  - The need for spiritual integrity, vision, and the ability to guide others in truth.
  - A call to be a servant-leader, modeling Christ's humility and love.
- The new Apostle is reminded of the weight of their calling to be a foundational leader in the church and the importance of spreading the gospel.

#### Commissioning:

o The new Apostle is formally commissioned for their work. This may include sending them out on a specific mission or assigning them to lead certain church initiatives. The commissioning is often a prayerful moment, with the congregation standing in agreement.

#### 5. Final Prayers and Worship

#### Blessing:

- o The service concludes with a final prayer of blessing and commissioning. The newly consecrated apostle may receive individual prayers from the congregation, and there may be a special moment of praise and worship in response to the new apostle's appointment.
- The apostle may be officially presented to the congregation as the newly consecrated leader, with a time for fellowship and celebration following the service.

#### 6. Reception and Fellowship

#### Celebration:

- After the formal affirmation, a time of fellowship and celebration may occur. This could involve a reception or meal, where the church family can greet the new apostle and express their support and congratulations.
- The new Apostle may take the opportunity to share their heart, vision, and gratitude with the congregation.

#### **Important Considerations**

- **Doctrine and Ecclesiastical Tradition**: Some denominations have very formal and hierarchical processes for Apostolic succession and affirmation. Others, like Pentecostal and Charismatic movements, might have more flexible or spontaneous procedures.
- **Apostolic Calling**: The candidate's sense of divine calling and confirmation from the Holy Spirit plays a crucial role. It is often seen as more than just an appointment; it is an acknowledgement of God's work in the individual's life and ministry.
- Certifications: Each new Apostle will be presented with the following documentation:
  - Certificate of Affirmation
  - Certificate of Consecration
  - Apostolic Line of Succession (Includes Book of Complete Line)
  - Certificate of Appointment
  - Certificate of Commissioning (Includes the Apostle's Creed)
- **Investiture**: The vestments of the new Apostle shall include the following:

  - Zucchetto (Male's only)
  - Mitre (Optional for Apostles)
  - Gold Pectoral Cross & Chain
  - Apostle's Ring
  - Bible (Can be personal one)
  - Croizer/Staff
  - Sword
  - Ministry Seal and Crest
  - Certificates & Documentation
  - The Apostolic Litany

In conclusion, consecrating an Apostle in the modern church is a sacred and communal event, combining elements of worship, prayer, and biblical tradition. It is a powerful affirmation of the individual's call to leadership within the body of Christ, and the ceremony serves as both a spiritual and practical commissioning for the Apostolic Five-Fold ministry mission.

#### Apostolic & Church Oversight of a Minister's License

Acts 13:2 As they ministered to the Lord, and fasted, the Holy Ghost said, Separate me Barnabas and Saul for the work whereunto I have called them. 3And when they had fasted and prayed, and laid their hands on them, they sent them away.

Matthew 5:23-24 Therefore if you bring your gift to the altar, and there disciple that your brother has something against you, 24 leave your gift there before the altar, and go your way. First be reconciled to your brother, and then come and offer your gift (NKJV).

Mark 11:25 And whenever you stand praying, if you have anything against anyone, forgive him that your Father in heaven may also forgive you your trespasses (NKJV).

Romans 13:1 Let every soul be subject to the governing authorities. For there is no authority except from God, and the authorities that exist are appointed by God. (2)Therefore whoever resists the authority resists the ordinance of God, and those who resist will bring judgment on themselves (NKJV).

#### **The Call to Examination**

The local congregation formally begins the process of ordination by confirming the call of the candidate to examination, and if they are found qualified for ordination. The recommendation statement is as follows:
Whereas Brother/Sister, a disciple of (name of church here), has given evidence that he (or she) is called of God to the Gospel ministry; and whereas we believe the time has come when he should be formally set apart to that work; therefore, be it
Resolved:
That we call Brother/Sister to examination, with a view to the ministry, and to ordination, provided that upon examination it appears to us that the time has come for such an action;
That we formed an Ordination Preparation Committee to examine his (or her) credentials;
That we called an Ordination Council to consider and pass upon the fitness of Brother/Sister, said council to meet with us at o'clock (A.M./P.M.), on the of [Year] and;
That we invite sister churches in this organization and the ELFM to send delegates to said Board of Ministry Standards and the Apostolic Council.

### ETERNAL LIFE FELLOWSHIP MINISTRIES Requirements for Ordination, Licensure, and Commissioning

Those seeking to become ministers in the ELFM must satisfy the ordaining Apostolic Council and local church body of their suitability and readiness for ministry.

#### All Ordination applicants must

- 1. \*Be of the age of Twenty-one (21) years old or older.
  - \*This requirement may be waived on a case-by-case basis.
- 2. Must pledge their acceptance to the Apostle's Creed.
- 3. Must pledge that they are called of God to be a minister/elder in the Gospel of Jesus Christ.
- 4. Must pledge their acceptance of the Apostolic Succession and Apostolic Authority of the church.
- 5. Must pledge an understanding that sacraments are a means used by God to impart grace and accept the real presence of Christ.
- 6. Must submit to a full credit and criminal background investigation.
- 7. Must complete ELFM ministerial training to exercise their respective gifts in ministries.

ELFM and the local church are admonished to exercise care in discerning the suitability and readiness of all applicants for ordination. ELFM ordinary jurisdictions provide sufficient educational opportunities through its institutes and seminaries for the training of those seeking ordination, licensure, and commissioning in the ministry when a local church lack suck training.

Ordinations take place within the worshiping community of the candidate. Ministers/Elders come from the people; they are not chosen by the hierarchy and imposed upon a local congregation. There are cases, however, where the candidate has no current worshipping community. In such cases, ordination can take place at a suitable location chosen by leadership. The candidate (or candidates) for ordination are encouraged to bring friends and family to support them.

ELFM with 2 Timothy 4:5 is nontraditional and provides organizational support for ministries, much like the early church. Since we are a church as defined in scripture, having an ecclesiastical form of government, 2 Timothy 4:5 can provide church ministry leadership the support they need.

2 Timothy 4:5 offers non-denominational ministries the ability to maintain autonomy and be a part of an association. Non-denominational ministries seeking a real ministry relationship with an established ministry dedicated to your success, 2 Timothy 4:5 is here for you. 2 Timothy 4:5 takes the ordination of God with great reverence whether He ordains and individual or church ministry.

ELFM and its Affiliates can be assured that 2 Timothy 4:5 is interested in their financial wellbeing. The ministry financial commitment is such that your ministry benefits from a Biblically based financial covenant with 2 Timothy 4:5. We encourage prospective applicants to read the ELFM.

Since April of 2008 we have been applying 2 Timothy 4:5 and reaching around the world with the gospel of Jesus Christ through the ELFM if you have a passion to reach lost people, are called of God, and are committed to help fulfill the great commission, we are enthusiastic to have you as part of the 2 Timothy 4:5

2 Timothy 4:5 uses very specific set of Biblical qualifications, administered by mature Christian leaders dedicated to serving The Lord Jesus Christ. We believe that scripture reserves ordination to God and Himself alone. "For we are his workmanship, created in Christ Jesus unto good works, which God hath before ordained that we should walk in them" (Ephesians 2:10) Therefore, ordination by man is subject to man's limitations, ordination by God is subject to God's limitless call.

#### The Licensure/Ordination Process & Guidelines

#### Introduction

Ordination is the responsibility of the local church. The following ELFM guidelines are not requirements for ordination or for future possible commissioning. However, information gathered in the ordination process may be helpful in the accreditation process, as well. These suggested guidelines are designed to assist local churches to better fulfill their ordination responsibilities and to assist candidates in their preparation for the Ordination Council.

#### **Review of the Licensure/Ordination Process**

- A. It is recommended the Council on Ministry be consulted regarding available ordination guidelines before the local church calls the candidate to examination.
- B. Ordination candidate prepares his/her credentials.
- C. Ordination Preparation Committee of the local church examines the credentials of the candidate to ensure the preparedness of the candidate for the Ordination Council.
- D. Ordination Council is called with association and denominational representation to examine the candidate and make a recommendation to the local church.

#### **Ministers**

- 1. Following receipt of a recommendation from the Ordination Council, the local church makes the final vote on the ordination of the candidate.
- 2. Ordination service is planned and carried out by the local church to take place no earlier than 27 days following an affirmative vote by the local church. The Ordination Preparation Committee of the local church will assist in the preparation of the candidate for the Ordination Council. Here are the suggested guidelines the church may wish to use for this new committee.

#### The Licensure/Ordination Preparation Committee

In order to encourage the preparedness of the ordination candidate, we urge local churches to establish an Ordination Preparation Committee.

#### **Purpose of the Licensure/Ordination Preparation Committee**

To carefully review the credentials of the candidate to see if they are in order for an Ordination Council and recommend that the church proceed with the examination and call to ordination.

#### Membership of the Licensure/Ordination Preparation Committee

The local church will choose the Ordination Preparation Committee. It can be established as a new group or an existing group in the local church (Diaconate, Advisory Board, etc.) may be chosen for this purpose.

#### The Role of the Licensure/Ordination Preparation Committee

The Ordination Preparation Committee should meet to carefully review the following suggested credentials of the candidate.

- 1. A written statement of the candidate's Christian experience.
- 2. A written statement of the candidate's call to the Christian ministry.
- 3. A statement of the spouse's support in this call would also be desirable and encouraging.
- 4. A verification of the candidate's educational background.
- 5. A resume of the candidate's work experience and/or previous ministry experience.
- 6. A written doctrinal statement on each segment of the Seventh Day Baptist Statement of Belief.
- 7. Three letters of reference regarding his/her moral character. One of these letters should be from a person outside the church but from the community where the person is ministering.

When the Ordination Preparation Committee is convinced that the candidate's credentials are in order and that the candidate is prepared for the Ordination Council, the church should be notified. At this time the church is ready to call for Ordination Council. Please send a copy of the above credentials (letters and documents) to the Council on Ministry to be placed in the pastor's file.

#### **Ordination and Sexual Conduct**

#### **Licensure/Ordination Standards**

When a person has demonstrated a call to ministry it is appropriate for the local church to call that person to ordination. The church issuing a call to ordination has the responsibility to consider the candidate's sincerity, faith, doctrinal understanding, morality, ability, and training for gospel ministries.

#### **Ministers**

#### **Licensure/Ordination and Sexual Conduct**

Sexual conduct is a significant part of the morality of a pastor being considered for ordination. Sex between a man and a woman in the bonds of holy matrimony is a beautiful, pure and powerful part of the marriage union. However, sexual activity outside of heterosexual marriage--such as fornication, adultery, and homosexual activity--is contrary to the will of God (1 Corinthians 6:9-10).

We recommend to local churches that they not ordain individuals to the gospel ministry who openly practice sexual activity outside of heterosexual marriage or are unrepentant of sexually immoral behavior as defined by scripture. (Past experiences should not be considered).

#### **Accreditation and Sexual Conduct**

ELFM does not extend or continue accreditation to individuals in the Gospel ministry who practice sexual activity outside the bonds of heterosexual marriage or are unrepentant of sexually immoral behavior as defined by Scripture.

#### **Stages of Credentialing**

- License: (This is issued conditionally) Supervised by the Local Church.
- **Ordination:** (This is issued for life) Acknowledges and recognizes God's calling you to operate your gift in ministry. Authorizes you to operate in your gift under the ELFM banner.
- **Commission:** (This is issued conditionally and requires membership in the fellowship). Approves you to fully operate (independently) with the full support and covering of the ELFM.
- **Appointment:** A Licensed and Ordained minister can be appointed to a position within the local church and/or fellowship. This is a conditional position and is subject to change without notice.

The purpose of a ministerial credential is to:

- Affirm God's call upon a person's life
- *Verify* that this person meets the qualifications and standards for ministry in the ELFM.
- *Approve* this person for ministerial service under the auspices of the ELFM.
- *Provide* legal status in the exercise of that person's ministry

There are five types of credentials in the ELFM:

- Ministry License (Vocational)
- Ministry License (Non-Vocational)
- Certificate of License
- Certificate of Ordination
- Certificate of Commission
- Certificate of Appointment

#### **Application Check List**

#### **Records and Certificate of Ordination**

A copy should be sent to ELFM so that it will be on file when accreditation by ELFM is sought and states: "This is to certify that after a satisfactory examination by a duly called council as to his (her) Christian experience, call to the ministry and religious faith (Name of Candidate) was licensed and/or consecrated to the Christian ministry by ELFM."



"When you become ordained by this council of churches you become part of a greater blessing, an anointed prophetic vision and a worldwide mission! You shall have great favor in the eyes of god and your ministry will grow and greatly prosper in all things and among all peoples of the earth!"

- 1. We believe and know that God exists and is pleased with all who draw nearby faith. We worship the one and only holy and loving God who is Father, Son, and Holy Spirit eternally. God has created all things visible and invisible, has brought salvation and new life to humanity through Jesus Christ, and continues to sustain the church and all things until the end of the age.
- 2. We believe in Jesus Christ, the Word of God become flesh. He is the Savior of the world, who has delivered us from the dominion of sin and reconciled us to God by his death on the cross. He was declared to be the Son of God by his resurrection from the dead. He is the head of the church, the exalted Lord, the Lamb who was slain, coming again to reign with God in glory.
- 3. We believe in the Holy Spirit, the eternal Spirit of God, who dwelled in Jesus Christ, who empowers the church, who is the source of our life in Christ, and who is poured out on those who believe as God's guarantee of redemption.
- 4. We believe that all Scripture is inspired by God through the Holy Spirit for instruction in salvation and all training in righteousness. We accept the Scriptures as the Word of God and as the fully reliable and trustworthy standard for Christian faith and life. Led by the Holy Spirit in the church, we interpret Scripture in harmony with our Lord Jesus Christ.
- 5. We believe that God has created the heavens and the earth and all that is in them, and that God preserves and renews forever what he has made. All creation has its source outside itself and belongs to God the Creator. God is good and provides all that is needed for life.
- 6. We believe that God has created human beings in his divine image. God formed them from the dust of the earth and gave them a special dignity among all the works of his creation. Human beings have been made for a loving relationship with God, to live in peace with each other, and to take care of the rest of creation.

- 7. We confess that, beginning with Adam and Eve, humanity has disobeyed God, given way to the tempter, and chosen to sin. All have fallen short of the Creator's intent, have marred the image of God in which they were created, disrupted order in the world, and limited their love for others. Because of sin, humanity has been given over to the enslaving powers of evil and death and only through the shed blood of Christ Jesus upon the Cross of Calvary can man be redeemed and receive salvation which is only by faith in the finished work of Jesus Christ.

- 10. We believe that the mission of the church is to proclaim and to be a sign of the kingdom of God. Christ has commissioned the church to make disciples of all nations, baptizing them, and teaching them to observe all things he has commanded.
- 11. We believe that the baptism of believers in the immersion of water is a sign of their cleansing from sin. An applicant, who meets all other requirements, will receive Candidate Status after a personal interview with the ELFM board. Full ordination will be issued after the educational requirements are met.

- 9. Beware of any demonic activity operating in the individual.
