ELFM is an international network of relational kingdom leaders that provide legal licensing, ordination, credentials, and non-profit status to some of the most innovative and passionate emerging leaders in ministry; including market-place ministers, missionaries, bi-vocational counselors and full-time ministers.

We are a group of men and women who desire to possess the full, rich life in Christ. We believe God is going to reach the nations with this gospel of the Kingdom, the same gospel that Jesus demonstrated when He was on the earth. We are seeking to be vessels filled with the Spirit who can reveal to the world a Living Christ. We desire to express the same divine compassion that Jesus did and release the same violent hatred for the works of darkness. We are not so much interested in being great men and women of God as we are in revealing a great and mighty God who uses average human beings. They that know their God shall be mighty and do exploits.

We seek to walk with those who long for the full, rich life that Jesus died to obtain for us. As Paul said, "Follow me as I follow the Lord." It is our desire that this same heart would be in us. We expect the miraculous. But we believe that the ultimate vision is to reveal a risen, glorified, victorious Savior, Who has died that all men might live. This was the passion of our Servant Leader and remains the foundational passion of ELFM.

ELFM endeavors to constantly encourage all who join to embrace the vision, emulate the integrity, embody the holiness, emblazon the boldness and emboss the authority of the Risen Christ.

Fellowship Partner

These are members of the Body of Christ who are not necessarily called to full time ministry, yet desire to partner with ELFM. Associate Ministers/Partners share the heart and vision of the ELFM and choose to support ELFM in prayer, finances, and attending ELFM functions, but do not feel the need to be licensed or ordained ministers, or become charter members. These individuals, churches or ministries can choose to become ELFM Associate Ministers/Partners. ELFM associate Ministers/Partners are invited to all conferences sponsored by ELFM and receive all mailings sent to our members.

Licensure

This level of membership is for those who require credentials to perform marriages and burials, and/or those needing access to prisons, nursing homes, hospitals, etc. Some states require ordination rather than licensing to perform these functions. In addition many of those who minister in healing rooms choose to be licensed. Licensed members include those who are in full-time or part-time ministry in churches, in ministries that operate outside the church, as well as those who are involved in market-place ministry. Licensing with ELFM involves an application process. This process requires recommendations from a pastor, a fellow minister, and a personal friend.

ORDINATION

The basic requirements for ordination are based on relationship with ELFM so we "know" you, your ministry calling, your commitment to the Lord, etc. Thus, those who have not been ordained by another organization are required to be a member of ELFM for at least one year before applying for ordination. Ordination is for those who are recognized leaders in a ministry either inside or outside of the church. We recognize the fact that it is really God who calls and ordains His people for His work. We simply come into agreement with Him and facilitate the process with the laying on of hands and prophetic presbytery by ELFM board members and other invited leaders with strong prophetic gifting at our annual conference.

Plant Churches

Licensed or ordained ministers may desire to be chartered under ELFM. We are legally able to provide IRS 501c3 status for churches and ministries that would like to obtain this status under our covering. To be eligible for an ELFM Charter, an ELFM member must first register their ministry name and become a non-profit corporation in his/her state. The application process includes appropriate paperwork for our records and the necessary IRS paperwork that is required for consideration of charter status. We provide sample forms from other ministries who are chartered under ELFM to help applicants fill out all the necessary forms. When the application process is complete, the IRS is notified and the member receives their Certificate of Charter.

Fellowship of Churches Application

Working together to network churches and ministers to fulfill the Great Commission.

Church Affiliation Governing Guidelines

I. Churches desiring partnership with the Fellowship should:

- 1. Be in agreement with the vision and values of ELFM
- 2. Be in agreement with ELFM Statement of Faith.
- 3. Be in agreement with ELFM Mission Statement.
- 4. Agree to build relationship with other ministers in the Fellowship.
- 5. Agree to actively participate in building the Kingdom of God through this body to the best of their ability.

II. Church affiliation requirements:

The Senior Minister of the church desiring affiliation must carry or obtain ELFM credentials.

- 1. Each church will be an autonomous body and, therefore, must have its own charter/bylaws. If the church is just beginning, ELFM can assist in establishing its charter/bylaws.
- 2. Each church has the option of obtaining its own 501(c) (3).
- 3. Each church must agree to certain standards in order to come under the 501(c) (3) Group Exemption of the LACC.
- 4. Each church will give <u>a minimum of \$1.00 per member each fiscal quarter</u> to the Fellowship <u>on a monthly or quarterly basis</u> to support the Fellowship and provide for its on-going growth.
- 5. Each church will be required to apply for affiliation and then be interviewed by a ELFM Presbyter.
- 6. Each church will be required to complete a 12-month entry review period. An ELFM Apostolic Team will visit newly affiliated churches within that period and give a report.
- 7. A proper system of financial recording <u>must be</u> functional in the ministry, reflecting financial integrity. The affiliated church <u>must submit a copy of its financial report at a minimum once a year, and within 30 days after the end of the financial year.</u>
- 8. Once a year the affiliated church will submit a report describing the ministry activities through the past year.
- 9. Each church should be committed to relationship, responsibility and accountability to the Fellowship and its apostolic team.
- 10. Each affiliated church should attend minimum 1 out of every 3 annual ELFM conferences (Senior minister or representative for the leadership.)

III. Fellowship with the ELFM Fellowship:

- 1. Recognized ministerial staff of affiliated churches is eligible to apply for and receive credentials from ELFM.
- 2. If an individual member of an affiliated church congregation desires to obtain credentials through ELFM he/she must submit an application. The application must be complete and accompanied by a written referral from the pastor of the affiliated church.
 - a) The application will be thoroughly reviewed by members of the ELFM Presbytery.
 - b) If the applicant is accepted for licensure or ordination, representatives of the ELFM Presbytery will be present to conduct or oversee the credentials ceremony in the affiliated church (if feasible). Otherwise, the applicant must make arrangements to attend a credentialing ceremony on the campus of Christ For The Nations.

IV. Benefits:

- a. Increased credibility through identification with a worldwide organization that emphasizes integrity and responsible Christian conduct.
- b. The Church has the opportunity to come under ELFM's 501(c) (3) Group Exemption status for tax exemption (Case-by-case basis).
- c. Churches will be able to receive guidance from the ELFM Presbytery and Executive Board.
- d. Presbyters will be available to minister to the local congregations and bring outside wisdom to the body..
- e. Churches may send their senior leaders and spouses for an all expense paid retreat to the ELFM Campus in IL. Travel to and from IL not included.
- f. Churches may use Placement services at LACC.
- g. Churches will have the opportunity to partner with ELFM mission's projects.

V. Fellowship Accountability:

- 1. We, as a fellowship, have the authority to remove a church from membership/affiliation if it is noncompliant with our vision, values, and statement of faith or charter.
- 2. The ELFM Fellowship of Ministers and Churches offers accountability to autonomous bodies.
- 3. As an affiliated member your church would be accountable to this fellowship only.

Please be aware that affiliation with ELFM Fellowship of Ministers and Churches <u>DOES NOT</u> entitle your church to include the wording "ETERNAL LIFE" in its name. You may, however, indicate that your church/ministry is affiliated with ELFM.

- License: (This is issued conditionally) Authorizes you to operate in your gift under the LOVING ARMS WORLD MINISTRIES & APOSTOLIC COUNCIL OF CHURCHES/OPEN ARMS FAITH ASSEMBLY banner.
- Commission: (This is issued conditionally and requires membership in the LACC). Approves you to
 fully operate (independently) with the full support and covering of the LOVING ARMS WORLD
 MINISTRIES & APOSTOLIC COUNCIL OF CHURCHES/OPEN ARMS FAITH ASSEMBLY
 banner.

- 13. Reconnecting the earth's history with the death, burial, and resurrection of Jesus Christ through affirming the biblical view of Creation.

LAWM/LACC/OAFA STATEMENT OF FAITH

The Fellowship holds to the Statement of Faith espoused by ELFM while recognizing the diversity of beliefs among Spirit-filled Christians of scriptural integrity. Therefore, we open the arms of this Fellowship to include and embrace all who hold to the foundational truths of the Christian faith.

- 1. The One True God: There is one living and true God, eternally existent in three persons: God the Father, God the Son, and God the Holy Spirit (Deut. 6:4; Matt. 28:19).
- 2. The Scriptures Inspired: The Bible is the only infallible, inspired, authoritative, written Word of God (2 Tim. 3:16).
- 3. The Deity of the Lord Jesus Christ: We believe in the deity of our Lord Jesus Christ, in His virgin birth, in His sinless life, in His miracles, in His vicarious and atoning death, in His bodily resurrection, in His ascension to the right hand of the Father, in His personal future return to this Earth in power and glory to rule a thousand years (John 1:1).
- **4.** Original Sin and the Fall of Man: We believe that man, created in the image of God, by voluntary disobedience fell into the depths of sin and iniquity, therefore passing on sin's nature and consequences to all mankind, with their accompanying loss of intended meaning and purpose (Gen. 1:27; Rom. 5:12).
- 5. The Salvation of Man: Man's only hope of redemption and salvation from the power of sin is to willingly choose repentance and faith in the shed blood of the Lord Jesus Christ, and that it is possible for a believer to lose his or her salvation by willfully turning away from the provisions of salvation which Christ has made. Salvation is a free gift from God and is available to any and all who call upon the Name of the Lord (Acts 4:12; Rom. 5:8-13, 15; 10:9, 13; Jas. 1:21; Eph. 2:8; Heb. 3:12, 6:4-6, 12:15; Matt. 13:22; 2 Tim. 4:10; 1 Tim. 1:19).
- 6. The Church and its Mission: We believe in the Great Commission to go into the entire world to make disciples (Matt. 28:19).
- 7. The Ordinances of the Church:
 - a. Baptism in water in the Name of the Father, Son and Holy Spirit. All who repent of their sins and believe in Christ as Savior and Lord are to be baptized. This is a declaration to the world that they identify with Christ in His death and have been raised with Him in newness of life (Matt. 28:19; Mark 16:16; Acts 10:47, 48; Rom. 6:4).
 - b. The Lord's Supper consisting of the elements—bread and the fruit of the vine—is the symbol expressing our sharing the Divine nature of our Lord Jesus Christ (2 Pet. 1:4), a memorial of His suffering and death (1 Cor. 11:26), and a prophecy of His second coming (1 Cor. 11:26), and is enjoined on all believers until He comes!

- 8. The Baptism in the Holy Spirit: The baptism of believers in the Holy Spirit with evidence by speaking with other tongues as the Spirit of God gives utterance (Acts 2:4). With the baptism in the Holy Spirit comes power for life and service in the ministry of the Body of Christ. We believe in corporate prayer with the believer's prayer language. (Luke 25:49; Acts 1:4, 8; 2:11; 10:46; 1 Cor. 12:1-31).
- 9. Divine Healing: Divine healing was provided for all in the Old Testament (Ex. 15:22-26; Ps. 103:1-3; Isa. 53:4, 5) and in the New Testament it is an integral part of the Gospel (Matt. 8:16, 17; Acts 5:16; Jas. 5:14-16).
- 10. The Final Judgment: We believe that all shall stand before the judgment seat of Christ: the redeemed to be delivered unto everlasting life, and the unrepentant unto everlasting punishment (Rev. 20:11, 12; 2 Cor. 5:10).

ARTICLE [xx]

AFFILIATION

While maintaining its inherent rights to govern its own affairs, this ministry shall voluntarily enter into full cooperative ministry affiliation with the ELFM Fellowship of Ministers and Churches executive office located in Waukegan, IL. It shall share in the privilege and responsibilities enjoined by that Fellowship, with the privilege of fellowship with other ministries of like precious faith.

Further, it is recognized that ELFM Fellowship of Ministers and Churches Inc. Shall not hold, enforce, or in any other way exercise any prerogative which shall be held in any court or body to be its legal right, with the exception of only such prerogatives as shall be specifically delegated to ELFM by the ministry. Such specific prerogative shall be returned in entirety to the ministry upon two-thirds vote of its membership, providing any and all obligations to ELFM. ETERNAL LIFE FELLOWSHIP MINISTRY has been dispatched. It is understood that the attitude and procedure of all individuals and ministries should be that of a compassionate and cooperative relationship toward ELFM Inc. in accordance with Philippians 2:3 and Philemon 14
