

## Waiver agreement and Liability release Please read carefully before signing



## Serious injury may result from horseback riding and other equine activities. THIS IS A WORKING FARM. Your safety cannot be guaranteed.

I \_\_\_\_\_\_\_\_\_ (name of rider and legal guardian), agree to assume all risks of injury arising out of participating in equine activities or any other activity while participating in and/or observing at Premier Equestrian Center LLC, either on or off the property or premise, while using, being around, riding, or in any other way associating with horses, cats, dogs, or any other animal that may or may not be owned by Premier Equestrian Center LLC. I release and agree not to sue or in any way initiate a law suit against Premier Equestrian Center LLC, its agents, employees, volunteers, servants, or any other person associated with Premier Equestrian Center LLC from any and all claims of injuries or damages sustained from equipment or animals or weather conditions or hazards while participating in an equine activity or other farm activity either on or off the property.

I agree not to invite or permit any other person(s) to enter the premises as my guest without signing a waiver agreement. Any such person shall be deemed a trespasser and not an invitee unless a waiver is signed.

All persons under age 18 (eighteen) must have a waiver agreement signed by both the participant and the legal guardian.

All people engaged in an equine activity or farm activity or permitting their child(ren) to engage in an equine activity acknowledges that equine activities can be hazardous due to the inherent risk of the equine activity and may result in serious injury or death.

INHERENT RISK OF EQUINE ACTIVITY MEANS A DANGER OR CONDTION THAT IS AN INTEGRAL PART OF AN EQUINE ACTIVITY, INCLUDING BUT NOT LIMITED TO, ANY OF THE FOLLOWING:

- a. The propensity of an equine to behave in ways that may result in injury, death, or loss to persons around the equine:
- b. Any animal(even good natured ones) may act in an unpredictable, dangerous, or vicious manner, including but not limited to: biting, striking, kicking, bolting, rearing, trampling, crushing, smashing, pushing, or bucking.

By signing this waiver agreement, I also indemnify **Premier Equestrian Center LLC** and its employees, servants, volunteers, agents, etc. from any loss, injury, illness, death of my own, my child, or my horse or other animal that I may choose to bring to the academy whether or not the injury, illness, death was the result of a person or animal associated with or owned by **Premier Equestrian Center LLC**.
