6:00 pm meeting Called to Order by Chair, Lisa Robinson

Agenda Items:

#1 Vote on repairs to Wells #4 & #5, estimated costs \$3,800 and \$7,000 to \$8,000 respectively.

Discussion: Well 4 already had a BFV drive, but issues with the electrical and won't know exactly the issue until it is pulled. Well 5 is just full of junk and the same as 4, they won't know the extent of the repairs until it is pulled. Until they clean it and pull, they won't know if we need a new pump.

Commissioner Grotheer: Do we have record of what recently was done to Well 4 that Aquamen hoped would fix the issue?

Robinson: Just the BFV drive that was on the wall was replaced, it was completely burnt out and fried. But since it is still not working, they are expecting it is an electrical issue with the pump.

Chair Robinson: yes, we discussed it, but we just got the proposal and that is why we are having an emergency meeting to get it taken care of right away.

MJ: Can you tell us where these wells are located?

Chair Robinson: Well 4 is at Franklin Pierce and Well 5 is at Peninsula.

Kathy Dymant: Are we getting billed for this?

Chair Robinson: No, this comes out of regular maintenance and is already collected through the taxes for the budget this year. There is no separate bill for anyone on this.
