### **Photography, Film and Social Media Policy:**

- To protect the privacy of our faculty and students, as well as the branding of Halcyon Dance Studio, absolutely no unauthorized photography or filming of any kind is allowed on the premises of Halcyon Dance Studio. This includes but is not limited to, studios, common areas, rehearsals, costume fittings, performances and events.
- Students participating in private lessons may film and photograph themselves for the sole purpose of retaining choreography and verbal notes, with approval from the instructor/choreographer.
- Rehearsals will be filmed/recorded in order to send out the most updated choreography and notes to any dancer who is absent, as well as the ones in attendance for the sole purpose of retaining choreography and verbal notes.
- Students may be asked to participate in social media trends for promotional purposes, and may opt out at any time, no questions asked.
- Halcyon Dance Studio's social media posts may not be used for any commercial purposes without written permission from Halcyon Dance Studio owners; Kristen or Derek Bailey.
- When Halcyon Dance Studio does post a photo, video or reel to social media, you may download, share and distribute the posts for your personal use. If you repost them, you must credit the original photo/videographer.
- Students will have the opportunity to have their photos taken professionally during dress rehearsal for every show. These photographs can be purchased through Halcyon Dance studio, and once purchased, you can use/post them however you wish, being sure to credit the original photographer.
- No personal cell phones or recording devices will be allowed in the studios by students during classes and rehearsals. This ensures a distraction free environment and promotes focus and learning. - Each of our shows will be filmed/recorded and we will have the video available for purchase. The video is not for commercial use without written consent of the original videographer.
