RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

In consideration of the services of Halcyon Dance Studio, I (the student/s), myself, or as the parent/guardian of my child/children, being permitted to utilize the facilities, services and programs at Halcyon Dance Studio for any purpose, including but not limited to observation or use of facilities or equipment, or participation in any off-site program affiliated with Halcyon Dance Studio. The student/s, for themselves and any minor children they are legally responsible for, hereby acknowledges, agrees and represents that he, she or they has, or immediately upon entering or participating with Halcyon Dance Studio will inspect and carefully consider such premises and facilities or the affiliated program. It is further warranted that such entry into Halcyon Dance Studio for observation or use of any facilities or equipment or participation in such affiliated programs constitutes an acknowledgment that such premises and all facilities and equipment thereon and such affiliated programs have been inspected and carefully considered and that the student/s finds and accepts the same as being safe and reasonably suited for the purpose of such observation, use of and participation by the student/s and the child/children.

IN FURTHER CONSIDERATION OF BEING PERMITTED TO ENTER HALCYON DANCE STUDIO FOR ANY PURPOSE INCLUDING BUT NOT LIMITED TO OBSERVATION OR USE OF FACILITIES, EQUIPMENT, OR PARTICIPATION IN ANY OFF-SITE PROGRAM AFFILIATED WITH HALCYON DANCE STUDIO, THE STUDENT/S AND ANY AND ALL MINORS/CHILDREN THEY ARE LEGALLY RESPONSIBLE FOR HEREBY AGREES TO THE FOLLOWING:

1. The student/s, on his, her or their on behalf and/or the behalf of such children they are legally responsible for, hereby releases, waives, discharges and covenants not to sue Halcyon Dance Studio, its directors, officers, faculty, employees and agents (herein referred to as "staff") from all liability to the purchaser or such children and all his, her or their person representatives, assigns, heirs and next of kin for any loss or damage, and any claim or demands therefore on account of injury to the person or property resulting in death of the purchaser, whether caused by the negligence of the staff or otherwise while the purchaser or such children are in, upon or about the premises or any facilities or equipment therein or participating in any program affiliated with Halcyon Dance Studio.
2. The student/s and any and all children they are legally responsible for, hereby agrees to indemnify, save and hold harmless the staff and each of them from any loss, liability, damage or cost they may incur due to the presence of the student/s or such children they are legally responsible for in, upon or about Halcyon Dance Studio premises or in any way observing or using any facilities or equipment of Halcyon Dance Studio or participation in any program affiliated with Halcyon Dance Studio whether caused by negligence of the staff or otherwise.
3. The student/s hereby assumes FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE to the student/s or such children they are legally responsible for due to negligence of staff or otherwise while in, about or upon the premises

of Halcyon Dance Studio and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with Halcyon Dance Studio. The student/s and any children they are legally responsible for further expressly agrees that the foregoing RELEASE, WAIVER AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by the law of the State of Utah and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

I FURTHER UNDERSTAND THAT THIS RELEASE AND INDEMNIFICATION SHALL BE BINDING ON MYSELF, MY CHILDREN AND/OR WARDS, AND MY PERSONAL REPRESENTATIVES AND HEIRS.

THE STUDENT/S HAVE READ AND VOLUNTARILY, ELECTRONICALLY SIGN THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT AND FURTHER AGREES THAT NO ROLE REPRESENTATIONS, STATEMENTS OR INDUCEMENT APART FROM THE FOREGOING WRITTEN AGREEMENT HAVE BEEN MADE.

BY SIGNING BELOW, I UNDERSTAND THAT:

1. I HAVE READ THROUGH AGREE AND UNDERSTAND THAT HALCYON DANCE STUDIO IS NOT RESPONSIBLE FOR ANY BODILY INJURY, DEATH OR PROPERTY DAMAGE THAT MAY OCCUR DURING THE 2026-2027 SEASON.

2. I UNDERSTAND AND AGREE THAT HALCYON DANCE STUDIO AND IT'S STAFF IS NOT RESPONSIBLE FOR ANY POTENTIAL HEALTH CONFLICTS OR SICKNESS THAT MAY BEFALL THE STUDENT/S THROUGHOUT THE 2026-2027 SEASON.
