4. Log of Treasurer's Actions

- Processed assessment payments; paid invoices; reconciled bank statements with PCA records.
- Maintained 2024 Member Account Log (contains resident contact information and assessment payment records).
- Maintained 2024 Checking Ledger & Budget Report.
- Prepared monthly finance report for August 2024.
- 2024 Invoicing:
 - The 2024 invoices were prepared between January 09 and 18. Most of the invoices were mailed to residents on 16-Jan, and all were mailed by 18-Jan. This year the payment deadline has been extended to 15-Feb.
 - 64% of accounts were paid by the 15-Feb-2024 deadline; as of 31-May 82% of accounts were paid for 2024.
 - The second invoice was sent out between 11-May and 15-May, with due dates of 24-May to 31-May.
- Phone Port from Verizon to Microsoft: Initiated 16-Aug; primarily being handled by MS Phone Number Service Center; Verizon repeatedly rejected the porting request, apparently because all customer information must be exactly correct; current transition date is 11-Sep.
- <u>Verizon Voice-Mail Problems:</u> The V-M service has been down for a week or two; cause unknown; a repair ticket was written by Verizon, but we have received no status reports; this won't matter after noon on 11-Sep when Verizon relinquishes the line.
- Google Rejecting PCA E-Mails: After the PCA started sending e-mails directly from M-S servers, G-Mail started rejecting all e-mails from the PCA, listing them as spam. We found that sending to no more than ten G-mail accounts at a time still works. Brandon says this is a common problem between M-S and Google; we will look into using a free MailChimp account to make it easier to send e-mail to all our residents.

2024 Asphalt Projects:

- All work completed by 23-Aug.
- The work generally looks good. Some of the basketball court end lines are painted over weeds that somehow did not get removed by either Harman's Outdoor Services or Dominion Paving (Dominion only removed weeds where it was necessary for the crack filling; I thought Harman's was going to line-trim the court perimeter). There are some gouges on the court; looks as though they were there at the time of sealing, so perhaps during our walk-around both the PCA and Dominion missed flagging them for repair.
