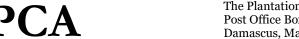

- <u>OuickBooks Online (OBO)</u>: This month the PCA's monthly membership converted from 50% discount to full price.
 - Next Steps: Configuring the software. We can purchase "expert" consultation time from QBO;
 they charge \$59 per hour, whereas the private accountants charge from \$225 to \$250 per hour.
- Prepared Draft-1 of the 2026 Budget. We are continuing our plan to increase the Reserve Fund
 contributions each year until we reach the recommended levels of the PCA 2023 Reserve Study; this
 requires raising the assessment levels.
- Responded to realtor and title company inquiries regarding property sales. Prepared three re-sale packages.
- Continued work to find an auditor for 2024. At present we have one acceptable price, one accounting firm quoting \$30K, and another saying their minimum charge is now \$15K (was \$5K in 2021).
