## Standard Park Rules

- Parks are open from dawn until dusk unless otherwise authorized by the PCA.
- Pets must be on a leash at all times and must not be left unattended. You must immediately pick up feces dropped by your pet.
- Tennis and basketball courts have a one-hour time limit when others are waiting.
- Bikes, trikes, roller blades, roller skates, skateboards, and pets are prohibited on the tennis court.
- Motorized vehicles are not allowed anywhere in the park.
- It is prohibited to damage, to deface, or to remove any PCA property.
- Household and/or commercial garbage dumping is prohibited.
- All fireworks are prohibited.
- Illegal substances are prohibited on PCA property.
- All grills and open flames are prohibited, except by permit from the PCA.
- Profanity, loud music, unruly behavior, and recklessness are prohibited.
- This park is not supervised. Engage in activities at your own risk.
- "Drop In" groups must vacate reserved areas when a group with a PCA permit arrives.

## Additional Rules for Groups Reserving Club View Park Facilities

- You must have your approved PCA park permit with you during your activity.
- Your permit will identify the areas that have been reserved for your group. You may not prevent other individuals or groups from using park facilities that are not reserved for your group.
- Parking for all participants and visitors to your activity must be on the park-side of the street, not on the side where residences exist. Overflow parking is on Log House Road and Bush Hill Road.
- No ground fires. Grills using propane or charcoal are allowed if listed on your permit, and attended.
- All special equipment must be listed on your permit (e.g., grill, generator, portable toilet, moon-bounce).
- Do not place large amounts of trash in the cans at the park. Please bring trash bags with you, and take overflow trash with you.
- Cleated footwear is not allowed on the playing field.
