White Americans are responsible for dismantling rigged advantage. *Twelve Steps for White America: for a United States of America* charts a future of strengthened security and global competitiveness. *Then*, our democratic republic thrives as a meritocracy where race does not predict outcomes. *Now*, race predicts outcomes.

Rigged advantage disproportionately benefits white Americans

Key indicator: The racial wealth gap is the largest of the economic disparities between Black and white Americans, with a white-to-Black per capita wealth ratio of 6 to 1.¹

Who is responsible for this work?

White Americans. Proficient practitioners of *Twelve Steps for White America* can support this work in companies, non-profits, and higher education.

ESG – DEI* practitioners can leverage this work as part of the strategies supporting organizational goals. They are not responsible for the work itself.

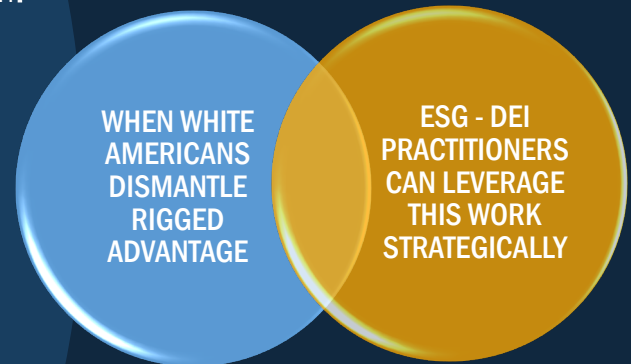
First Things First

Black, Indigenous and other People of Color must not be charged with dismantling the advantage which is rigged against them.

ESG and Diversity, equity, inclusion commitments signaled in the wake of the murder of George Floyd *must be built upon the foundation* of white Americans taking responsibility for dismantling rigged advantage. Justice then liberty leads to peace and prosperity.

Without the dismantling of rigged advantage, DEI² practice is fraught.

* ESG Environmental, Social, Governance (*categorical considerations for investing*)
+ DEI Diversity, Equity, Inclusion (*capacity for outcomes*)
= INTEGRITY Integrated alignment of “walk & talk” catalyzes performance

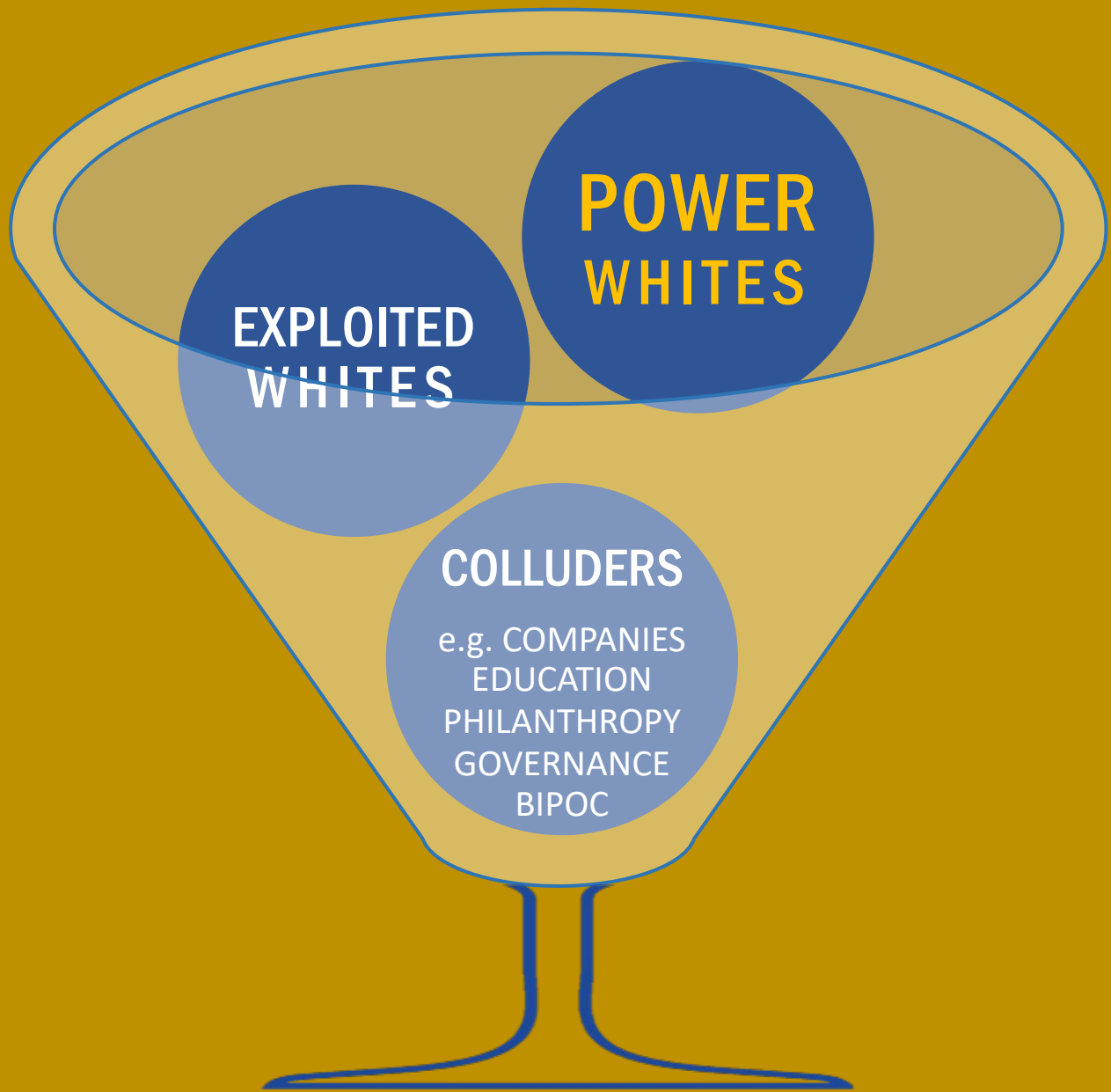
² DEI may also include justice and belonging to form DEIJB. Operationally, the foundational order of the work is justice, diversity, inclusion, belonging then equity. Justice is only possible when rigged advantage is dismantled. Equity is a measurable outcome available when JDIB is functional. (BJEDI is a tempting order, mnemonically, but that order is not operational).

STEP		LEARNING OUTCOME
1	We admit our problem: rigged advantage.	Identify the gap between presented & realized democracy in the U.S.
2	We believe something can be done.	Recognize the potential for personally impacting democracy's promise.
3	We decide to act.	Determine the need for a personal program of liberation for the common good.
4	We detail the problem.	Identify, analyze, and categorize specific knowledge, skills, and abilities rooted in Whiteness-affiliated rigged advantage.
5	We present the problem.	Recognize, describe, and present specific knowledge, skills, and abilities rooted in Whiteness-affiliated rigged advantage.
6	We resolve to change.	Contrast intentional vs unintentional beliefs and behaviors that reproduce rigged advantage, then dedicate self to a merit-rich democracy.
7	We humbly turn toward change.	Relinquish Whiteness-affiliated rigged advantage to habituate justice, then liberty for all.
8	We identify the harm.	For peace and prosperity, formulate remedies that eliminate disparities in socio-economic outcomes.
9	We repair the harm.	For peace and prosperity, implement remedies that eliminate disparities in socioeconomic outcomes.
10	We remain vigilant.	Habituate rigorous self-assessment to sustain justice then liberty, replacing periodic remission of rigged advantage with its eradication.
11	We choose reverence.	Synthesize personal spiritual discipline as the pathway to relinquish rigged advantage for the common good.
12	We consecrate liberty free from rigged advantage.	Dismantle rigged advantage for an integral democracy where competition thrives from race-neutral merit.

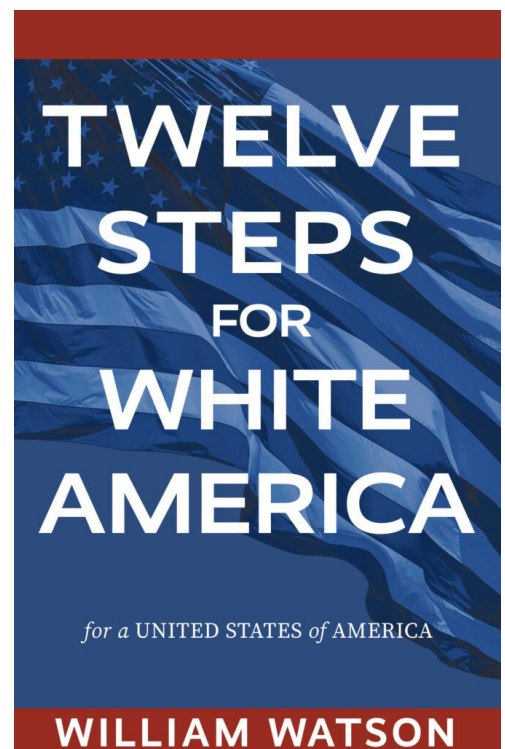
