A regular meeting of the Board of Trustees of the Village of Denton, Nebraska, was held at the Denton Community Center, on September 19, 2024

Chair Hobelman called the meeting to order at 6:45 p.m. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Trustees present: John Juricek, Amanda Fangmeier, Doug Rosekrans, Joe Hobelman, and Trent Wheatley.

Open Meetings Law. Chair Hobelman mentioned that the open meeting laws are posted on the wall.

Optimistic Club of Denton presented Joe Hobleman as the citizen in Denton Supporting youth in Denton for 2024.

1. Budget 2024-2025 Public Hearing

Open Hearing 2024-2025 Budget. At 6:55 p.m. Juricek motioned to open the public hearing. Wheatley seconded. Carried.

Presentation of Budget. Carmen Stanely from HBE talked to the board about the village's financials. She reminded the board you can not use tax funds to pay for utility funds. Currently the keno funds transferred into water and sewer help the funds to operate. No public comment.

At 7:03 p.m. Juricek motioned to close the public hearing. Fangmeier seconded. Carried.

2. Notice of Hearing to Set Final Tax Request of 24-25 Budget

Open Public Hearing. At 7:04 Juricek motioned to open a public hearing for the final tax request for 24-25. Fangmeier seconded. Carried. The tax request breakdown is \$68,727.20 for non-bond purposes and \$33,000 required for the water bond. Public Comment. No public comment. At 7:08 p.m. Juricek motioned to close the public hearing. Rosekran seconded. Carried.

3. Notice of Hearing to Set Final Tax Request of 24-25 Budget.

At 7:12 p.m. Juricek motioned to open a a public hearing for the 24-25 Budget. Second by Rosekrans. Carried. At 7:14 p.m. Juricek motioned to close the public hearing. Seconded by Wheatley. Carried.

1% Budget Additional Levy. Juricek motioned to exceed the budget limit by an additional 1% increase of restricted funds for the budget year of 24-25. Fangmier

Seconded. Unanimous. Juricek motioned to increase the 24-25 tax request by 2.5%. Seconded Fangmier. Unanimous.

Juricek motioned to pass Resolution 24-9-1 Levy Authority. Wheatley seconded. Carried.

Vote to approve the budget. Juricek motioned to approve the budget for 24-25 Fiscal Year. Rosekrans seconded. Unanimous.

Fangmier motioned to approve a property tax request of \$101,727.20 and a levy of .482685. Fangmeier seconded. Unanimous.
