





Proposal summary

We are proposing to remove environmental assessment requirements for the York1 waste disposal site project through the proposed *Protect Ontario by Unleashing our Economy Act, 2025.*

Summary of ERO 025-0389

If Passed:

- Environmental Assesment Requirements would no longer be required
- Revoke Ontario Regulation 284/24

Proposed Legislation

To help provide additional waste capacity in Ontario due to the threat of US tariffs impacting Ontario's waste sector, the province is proposing to remove environmental assessment (EA) requirements for the York1 waste project through the proposed *Protect Ontario by Unleashing our Economy Act, 2025.*

This would include revoking Ontario Regulation 284/24 designating Chatham-Kent Waste Disposal Site and removing environmental assessment (EA) requirements for York1 Environmental Waste Solutions Ltd.'s proposal to resume landfill operations and expand waste handling, processing, and transfer operations at the former Dresden Tile Yard, in Chatham-Kent (the Project).

The proposed legislation, if passed, would:

- Revoke Ontario Regulation 284/24: Designation Chatham-Kent Waste Disposal Site, which
 designates the Project as a Part II.3 project requiring a comprehensive environmental
 assessment; and
- Amend the Environmental Assessment Act (EAA) to exempt the Project from other EA requirements.

The project will remain subject to strong provincial oversight and other regulatory requirements including Environmental Compliance Approvals (ECA) under the *Environmental Protection Act* (EPA) and *Ontario Water Resources Act* (OWRA).

Summary of ERO 025-0389

Included Summary of the Project Includes:

- Construction of new processing and sorting building capable of indoor storage
- Installation of stationary equipment for processing construction & demoition waste into ALCF in the new processing/ sorting building
- Placement of mobile diesel powered shredding/
 grinding equipment for wood/construction & demolition
 waste outdoors
- And much more!

Proposed project

York1 Environmental Waste Solutions Ltd. is proposing to build an 8-hectare engineered landfill cell and re-establish landfill operations at an existing landfill site, including construction of any other works or facilities such as onsite roads, and fencing to receive waste and restart waste management activities and landfilling at the site, located at 29831 Irish School Road, in the former Township of Camden, Municipality of Chatham-Kent, Ontario.

The existing landfill site has a theoretical approved capacity of 1,620,000 cubic metres to landfill non-hazardous solid waste including construction and demolition waste and excess soil that are not reusable.

As part of the project, York1 Environmental Waste Solutions Ltd. is also proposing to re-establish and expand waste processing and transfer operations at the site, including expanding the existing 0.8-hectare waste processing site to 25 hectares.

Other activities are also anticipated, including:

- · the construction of a new processing and sorting building capable of indoor storage
- the addition of waste classes for accepted and processed waste
- installation of stationary equipment for processing construction and demolition waste into alternative low-carbon fuels (ALCF) in the new processing/sorting building
- placement of mobile diesel-powered shredding/grinding equipment for wood/construction
 & demolition waste outdoors
- installation of a soil treatment/soil washing system for processing solid and liquid soil to recover sand and aggregate material
- construction of stormwater management infrastructure

Summary of ERO 025-0389

If Passed:

- Existing ECAs will allow the facility to operate
- Modifications to the waste disposal site will be subject to ECA requirements for air, noise,
 emissions, waste management activites &
 sewage works

Permitting requirements for the project

There are existing ECAs under the EPA for the site, which allow for an 8-hectare landfilling area and for a 0.8-hectare waste processing site within the 35-hectare property.

Modifications to the waste disposal site will be subject to ECA requirements for air, noise emissions, waste management activities and sewage works under the EPA and OWRA for the landfill site, as well as the processing and transfer facility.


If the legislation is passed, it would come into effect on Royal Assent.

Dresden's Current ECA

Existing Environmental Compliance Approval for Waste Storage, Transfer and Processing - ECA A020401

Given under the Environmental Protection Act, 1990 on October 9, 1998.

- Site usage limited to storage, transfer, and processing of non-hazardous solid waste from industrial, commercial, institutional, and municipal sectors.
- Operations confined to 0.8 ha (2 acres) of the site, accepting a maximum of 75 tonnes per day, with a storage limit of 75 tonnes on-site.
- Hours of operation: 7:00am 9:00pm, Monday to Saturday



Dresden's Current ECA

Given under the Environmental Protection Act, 1971

Authorization granted for the operation of an 8-hectare landfilling site within a total site area of 35 hectares.

Permitted for disposal:

- 5% commercial waste
- 95% "Other" waste, limited to incinerator ash.



Previous Steps Taken by Council & the Community

Once these applications came to the attention of the Municipality and local community, formal opposition was submitted to the

Province through the Environmental Registry of Ontario (ERO).

- Council unanimously opposed the proposal and instructed staff to hire expert legal and engineering professionals to advocate for our community.
- A major request from the Municipality was for the Minister of the Environment to require a full Environmental Assessment for the proposed site.

Previous Steps Taken by Council & the Community

- Community opposition to the proposal was strong and widespread.
- Numerous submissions were sent to the Province, highlighting potential risks to our town, local economy, children, and the environment.
- On June 28, 2024, the Minister of the Environment approved Ontario Regulation 284/24, mandating a full Environmental Assessment.
- This decision requires the property owner to conduct extensive additional studies and ensures that community concerns can be formally raised through a structured consultation process.

Recent Provincial Change in Direction

- On Thursday, April 17, 2025, the Province introduced legislation titled Bill 5: Protect Ontario by Unleashing Our Economy Act, 2025.
- Included in this legislation are provisions to repeal Ontario Regulation 284/24, effectively overturning the requirement for a full Environmental Assessment for this property.
- The legislation also proposes to exempt the project from other approvals typically required under the Environmental Assessment Act.
- If Ontario Regulation 284/24 is revoked and the project is exempted from Environmental Assessment requirements, the property owners would only need to obtain approval from the Ministry of the Environment, Conservation and Parks (MECP) for new or amended Environmental Compliance Approvals (ECAs).

Recent Provincial Change in Direction

- If the Environmental Assessment process remains in place, it would require comprehensive studies on the proposal's potential impacts including traffic, the natural environment, socio-economic factors, and human health risks.
- Under the Province's proposed new approach, significantly fewer studies would be required.
- This approach would also remove most opportunities for public and community input on the project.

What's the Municipality Doing?

- The Municipality has re-engaged expert lawyers and engineers who supported Chatham-Kent in 2024.
 - Exploring all legal options
 - Preparing engineering support for a full Environmental Assessment
 - Submitting a formal objection to the Environmental Registry by May 17
- Reaching out to local MPPs, the Minister of the Environment, and the Premier to raise concerns about the serious impacts on

Dresden and Chatham-Kent

• Developing a Community Coalition

Comprehensive Environmental Assessment VS ECA

Comprehensive Environmental Assessment (EA):

- Broad review of environmental, social, health, and economic impacts.
- Requires multiple expert studies (traffic, ecology, human health, etc.).
- Public consultation is mandatory and built into the process.
- Can result in major project changes or cancellation.
- Takes place early in planning, before approvals or construction.

Environmental Compliance Approvals (ECAs):

- Focuses only on specific technical aspects like emissions or discharges.
- Requires fewer studies and narrower analysis.
- Public input is minimal or not required.
- Does not address broader community or health impacts.
- Issued late in the process, after the project is mostly finalized.

Why is it important we comment?

- This is an incredily unique ERO submission
- May be one of the highest commented EROs in history
- York1s comment extremely stressed that they did NOT want to do a EA
- The last EROs submitted about this project received over 500 comments.
- By continuing to submit comments, we show the MECP that this issue remains important and top of mind for the community.

Our Concerns

1. Sets a Dangerous Precedent

- Skipping an EA undermines Ontario's environmental protection process.
- Signals to other developers that environmental oversight can be avoided.
- Weakens public trust in the Ministry of the Environment's role as a watchdog.

2. The Site Is Based on a Permit from the 1980s

- The world has changed so have environmental standards and community needs.
- Basing a modern dump on outdated permits ignores new risks and realities.
- The original permit was for a different type and scale of project.

3. The Location Is Problematic

- The site is near homes, farms, and water sources.
- Risk of groundwater contamination and air quality issues.
- Threatens the health and wellbeing of Dresden and surrounding areas.

Our Concerns

4. Environmental Risk Without Oversight

- No EA means no baseline environmental studies or mitigation plans.
- No plan for dealing with potential spills, leachate, or accidents.
- No strategy for protecting endangered species or ecosystems nearby.

5. Long-Term, Irreversible Impact

- If approved, the dump will affect the area for generations.
- Once it's built, it cannot be undone.
- Future residents will be forced to live with the consequences.

6. The Ministry Has a Duty to Protect Us

- The Ministry's role is to safeguard our environment not to bypass its own safeguards.
- EAs are not a burden; they're a critical tool for accountability.
- Dresden deserves the same protections as every other community in Ontario.

Our Concerns

7. Mistrust of Incoming Company:

- False Reporting: York1 and The Recycling Depot GP Inc. were convicted for submitting false and misleading information to the Ministry of the Environment.
- Missed Shipments: They failed to report 458 inbound soil shipments in their 2021 annual report.
- Clerical Errors?: The defendants admitted to mistakes but only corrected the report after being caught.
- Fines: Both companies were fined \$25,000 each + a \$6,250 victim surcharge, with three months to pay.
- Lack of Transparency: This incident highlights serious concerns about their lack of transparency and responsibility.
- Community Impact: If they couldn't meet basic regulatory requirements in Toronto, how can we trust them here in Dresden?
