## LAKE HOLLYHILL ACRES PROPERTY OWNER'S PARK & LAKE RULES:

As a member in good standing, the recreational facilities of Lake Hollyhill Acres are for your use. But, unfortunately, sometimes this privilege is abused by our guests, uninvited visitors, and a few of our property owners. For this reason a set of Rules and Regulations have been adopted by your Board of Directors. If you and your guests will abide by these "Rules and Regulations" the enjoyment of all and the value of your property will be enhanced immensely.

- (1.) Fishing is allowed on the lake but you may NOT fish off the pier or in the swimming area.
- (2.) Trotlines and nets are PROHIBITED.
- (3.) There is a limit of (3) fish per person and BASS less than 16 inches in length MUST be returned to the lake.
- (4.) There will be NO frog gigging (hunting of frogs) at night.
- (5.) NO LIVESTOCK is permitted in the lake or on Association park properties. This means NO horses, goats, sheep, etc.
- (6.) Dogs MUST be on a leash while in the parks or lake area.
- (7.) NO firearms on Association properties.
- (8.) NO motorized vehicles on dam or in parks. This includes: motorcycles, go-carts, 4-wheelers, Mini-bikes, (except for maintenance vehicle).
- (9.) NO gasoline motors on lake.
- (10.) NO travel campers, tents, or overnight camping allowed on Association property at any time.
- (11.) All minors, under 12, MUST be accompanied by an adult AT ALL TIMES while swimming.
- (12.) NO assembly or group will be allowed to monopolize any park or beach at anytime.
- (13.) ALL parties are expected to clean up area used or be subjected to a fine.
- (14.) Do NOT leave trash or garbage on park properties.
- (15.) Do NOT throw cans, bottles, etc. into the lake.
- (16.) In order to prevent probable seepage, do NOT dig in lake without prior approval of The Board of Directors.
- (17.) Dress, decorum and language should be decent and in acceptable taste. "Thong bikinis" are NOT allowed.
- (18.) Former or present property owners, who owe maintenance fees to the Association, CANNOT use Association facilities as guests of paid members.
- (19.) ONLY property owners in good standing, as to payment of maintenance fees, are eligible to use the Association facilities.
- (20.) There will be a \$125.00 deposit for ANY property owner who reserves the park area for family gatherings, parties, etc. This deposit will cover any garbage, bottles, & trash left behind from the party if not picked up by the property owner after the party.
- (21.) For every 50 people you invite to the park for parties, etc., you MUST furnish a <u>Uniformed Police Officer</u>, if alcohol is to be served at the park.
- (22.) The Board of Directors issues a lake pass every year to our property owners in good standing. This year we have decided to charge \$3.00 for lost, or misplaced passes.
- (23.) The parks, dam and lake are OFF-LIMITS between 9 P.M. & 7 A.M.
