#### **Background**

Stewardship Development is currently seeking qualified contractors for a competitive proposal on the construction of a multi-family housing facility. The project will be funded, in part, with funds from the Harris County Treasury ARPA Multi-Family Acquisition Program. The project site will also feature a playground, two dog runs, a pedestrian walkway system, and designated bike parking areas. Other essential components of the site development include a driveway system serving approximately 110 surface parking spaces, two trash/recycling enclosures, and a stormwater management pond.
