B. Announcements from the Board

- 1). 2016 Road Work Plans to continue ship sealing on Brewer, Conestoga and Sharmiden Roads. Continue adding gravel to edges of pavement as needed.
- 2). Suggestions to: trim growth on Brewer just past Iron Horse to improve visibility. Add a white divider line as a trial on Brewer past Egbert Hill to slow speeding and keep cars on their side. Replace some of the reflectors as needed. Refresh white paint line on edge of road on curb on Brewer where it drops off. Add some new 25 MPH speed signs as needed. Discussed renting a solar 'see your speed' sign, but decided not worth the expense. Speeding is a very real problem in here. Suggested that we need a sign for Iron Horse saying No Outlet and a sign for those in Black Oaks stating "Welcome to Golden Oaks Please Respect our 25 mph speed limit

Suggested we should get car stickers saying Golden Oaks so people living in here can display

- 3). Board is looking into adding some adhesive speed bumps as a trial.
- 4). Emigrant trail update (Debbie reported that there has been no new progress and Ed Scofield addressed (see below)
- 5). Mailboxes update: Bill Checkvala replaced solar lights on Brewer Road mailbox and bulletin board structures with a newer and better version.
- 6). Original entry sign at Brewer and Hwy 49 has been refreshed with paint and will be getting a new solar on at dusk light. Bruce Hunt stated that lighting there adds to safety.
- 7). Update on Golden Oaks website www.goldeoaksassociation.com
- 8). Emergency List Update: sign-up sheet available to add your name or change status info will be added and updated you can request a new list from Debbie

- 2. Ed Scofield, County Supervisor
 - -Combie/Magnolia Roads Power and Phone lines should be completely underground by 2018
 - -Interceptors on traffic lights at Combie/49 and other lights along 49 will be installed this year to allow emergency vehicles to control lights
 - -Any future to construct an Emigrant Trail has too high a cost for the county
 - -Pot Ban (Measure W) will be on the June Ballot to decide to uphold the current ban on outdoor grows or change it
 - -right now up to 12 plants can be grown legally indoors in a permitted structure
