7). 2015 Brewer Road entrance upgrades –Caltrans will construct an entrance lane and improve narrow entrance summer of 2015. We will do work on our side as needed.

8). Scott Miller (Golden Oaks member and elected Director for our area at NID) NID treated water pipeline Phase 1 work is completed and ends at the intersection of Pioneer and Salt Creek Roads. 2nd phase to be done in summer of 2015 from behind Alta Sierra to Brewer Road in Lodestar. 3rd and final leg planned for 2016 that will attach the 1st and 2nd phase pipelines. D. Guest Speakers

1). Jerry Good, Higgins Battalion Chief – we are considered an urban interface area. He secured a 2 year grant to keep staffed. Asked for support for newest ballot measure later this year. Campfire permits can be obtained online. Higgins covers Golden Oaks from the South Wolf Creek south. North of the creek is covered by Consolidated Fire, but they both respond to our entire area. He is seeking money from state funds to install Traffic Signal light preemption for the lights at Combie/49, Alta Sierra/49, and Lime Kiln/49 so emergency vehicles can use to gain safer and faster entry. <u>http://higginsfire.org/About_Us.html</u>

2). Ed Scofield, County Supervisor – Discussed work of the Transportation committee in helping to facilitate Brewer and Hwy 49 improvements. Overlay of hwy 49 from Bear River to Grass Valley this summer. Citizens for Hwy 49 Safety have been instrumental in rumble strips along Hwy 49. Some discussion of the cost to the county for an Emigrant Trail (county does not have the money)

3). US Dept. of Agriculture, Larry Lane, Wildlife Trapper – there is no relocation of wild animals by this dept in CA. private persons do that – ie: rattle snakes. Problems with wild animals can be reported to County Agriculture Dept. He suggested the best way to protect small animals from predators (ex-chickens) is to use shade screen to 3 feet tall around enclosures because fox and other predators need to see the prey.

4). Agricultural Biologist with our county, Preston Newfield, discussed noxious weeds and their eradication. They have a crew from May-Oct. for some programs. Weeds that are rated A and B are considered prolific and invasive and property owners may be able to get help eradicating these with funds from Fed and State programs Star Thistle is rated C. He brought pamphlets (Debbie Porter may have some to share after meeting).
